AAOM International Conference and Exposition

Ms. Coleton and Mr. Hackler provided an update regarding the national meeting and reported that membership within the organization has decreased 11% and AAOM is looking at reasons for this drop and how to increase membership noting legislative changes being introduced at the federal level involving limiting the scope of practice for acupuncturists.

It was also reported that FAOMRA is looking at developing a data base of disciplinary action taken by states. Dr. James and the executive director explained how the Missouri State Board of Chiropractic Examiners participates in a database assembled by the Federation of Chiropractic Licensure Boards. Ms. Coleton and Ms. Kessler will forward information to FAOMRA concerning the chiropractic Federation's database.

Finally, the advisory committee indicated a link from its web site to AAOM and other national organizations of interest to acupuncturists would be helpful.
