**Acupuncture Detoxification**

The committee discussed the setting where auricular detoxification can be administered. Section 324.475 (2) RSMo defines an auricular detox technician as, “a person trained solely in, and who performs only, auricular detox treatment. An auricular detox technician shall practice under the supervision of a licensed acupuncturist. Such treatment shall take place in a hospital, clinic or treatment facility which provides comprehensive substance abuse services, including counseling, and maintains all licenses and certifications necessary and applicable.” Greg Boyle provided an email to the advisory committee that explained the legislative history of the language of the statute.

The executive director reported that a letter had been sent to the national association regarding the May 19-22, 2011 national meeting in Kansas City; however, no response had been received.


**Meeting Schedule**
