Nationwide there has been an increased dissemination and recognition of the practice of applied behavior analysis (ABA) which has inevitably led to increased efforts to regulate that practice. Over two (2) years ago in Missouri

through support from the Behavior Analyst Certification Board (BACB), the Association of Professional Behavior Analysts, the Missouri Association for Behavior Analysis, Autism Speaks, and numerous other organizations in the form of advice, letters, lobbyists, and feedback was instrumental in enabling the individuals of Missouri to take an important step in disseminating the science of behavior analysis and

establishing standards for behavior analytic services.

Behavior analysts and consumer advocates worked together to create a viable licensure program managed by a behavior analyst licensing board, despite the relatively small number of potential licensees in the state.

Thanks to the unified efforts of numerous families, behavior analysts, Division of Professional Registration, educators, lobbyists, and others, there are 197 BACB certificants in Missouri now licensed.

As the board moves forward in its role of maintaining the integrity of ABA services we hope the Missouri licensure program can serve as a model for other states.



The Board Members and Staff would like to extend our thanks to **Dr. Jessa Love** for her service on the Behavior Analyst Advisory Board (BAAB). Due to a move out of state, Dr. Love resigned her position on the BAAB effective June 13, 2013. We wish her all the best.

BOARD MEMBER APPOINTMENT PROCESS

Members of the Behavior Analyst Advisory Board (except for the one (1) professional member of the State Committee of Psychologists) are appointed by the Governor upon the recommendation of the director of the Division of Professional Registration and upon advice and consent of the Senate. Appointment of the one (1) professional member of the committee is made by nomination and majority vote of the State Committee of Psychologists. A Behavior Analyst or Assistant Behavior Analyst member is appointed for a five year term, and is eligible to serve for no more than two full terms. The membership of the Board is to be three (3) licensed Behavior Analysts, one (1) licensed Assistant Behavior Analyst, one (1) licensed Behavior Analyst holding a doctoral degree, one (1) public member and one (1) professional member of the committee.

To be considered for appointment, individuals must be licensed as a Behavior Analyst or an Assistant Behavior Analyst, United States citizens and residents of the state of Missouri for at least one (1) year and must be licensed for a period of at least three (3) years prior to appointment except for the original members of the Board.

The staff nor the current members of the Behavior Analyst Advisory Board have any involvement in the recruitment or appointment process. Beginning December 10, 2010 Missouri began licensing Behavior Analysts and Assistant Behavior Analysts for the first time.

Individuals who have been licensed as a Behavior Analyst have been issued a license that will expire on October 31, 2013 and those licensed as an Assistant Behavior Analyst have been issued a license that will expire on November 30, 2013.

Behavior Analysts will receive a renewal notification in September 2013 and Assistant Behavior Analysts will receive a renewal notification in October 2013. Please make certain our office has your current mailing address prior to August 29, 2013.

Also, remember that in order to renew the license your Behavior Analyst Certification Board (BACB) certification must be current. Upon receipt of your renewal and fee our office will be verifying the certification status so remember to allow extra time for that process. We do realize this is the first time you will have gone through the renewal process so do not hesitate to contact our office if you have questions.


