

The executive director provided information on the election of officers.

Financial Report

The board reviewed the income and expenditures for the current fiscal year. Dr. Thompson inquired about a possible fee reduction for the upcoming renewal cycle. The executive director reported that at the end of June the fund balance report would be reviewed with the division to determine if a fee reduction was possible. A fee reduction would require an emergency regulation, noting the statute allows for such amendments to accommodate a fee reduction or increase. A motion was made by Dr. Carver and seconded by Dr. Rushin to approve the financial report. Board members voting aye: Dr. Thompson, Dr. Rushin, Dr. Carver, Mr. Nahon, and Dr. Madosky. Motion carried unanimously.

Regulatory Changes

The executive director requested clarification from the board regarding changes to the MTAA regulation, adding the national examination administered via the ACA Council of Chiropractic Acupuncture (CCA) and the American Board of Chiropractic Acupuncture (ABCA). Specifically, the 100 and 300 hour course of study allows a person to take the national examination. The board instructed the executive director to draft the regulation to reflect that the board must approve the course of study if it is to be used toward the educational requirement for acupuncture.

Bax 3000

Clarification is needed regarding the phrase "FDA clearance" as used in the Bax 3000 promotional information. In an email from Dr. Hancock there is reference to the use of vials and the regulations prohibit this practice. The board instructed the executive director to draft a letter, to be reviewed by counsel, regarding these areas and send to Dr. Hancock

NCV and Needle EMG

The board reviewed the request for information from Dr. Wilczak and Dr. Carver stated he research the topic more fully and report to the board. Staff was directed to ask Dr. Wilczak if she had taken the course from New York Chiropractic College or Palmer.

FCLB & NBCE Annual Meeting

Dr. Carver provided an overview of the two annual meetings he attended in May of this year. The board discussed a recent email concerning a change in leadership at NBCE regarding the officers and directors. Dr. Carver was asked by the board to serve as the board's liaison and staff to work on a letter regarding the continuing high cost of the national examination.

MTAA Continuing Education

The board discussed the twelve hours of formal continuing education to maintain the certification. The executive director provided information regarding section 331.030.9(2) RSMo that requires the board to establish minimum and continuing education requirements for all specialties. No official action taken by the board.

MSCA Annual Meeting



Seventh Hour

From Chinese medicine, attendees will learn the causes and solutions for reduction of lower burner (lower abdominal area) – Small intestines and Large intestines. The effects of specific acupuncture points, diet, lifestyle, Chinese herbs and western supplements will be discussed

Eighth Hour

Attendees will learn specific ear acupuncture points that can increase the three “burner” flow of qi (energy) so that body metabolism can function effectively. Attendees will learn how to best communicate a weight reduction program to patients.

Classroom

First Hour

Prior to working with patients on any weight reduction program, it is important to establish the patient's size at commencement. Attendees will learn how to take inventory of a patient's body weight and size, including measurements of their chest, navel, hips, arms and thighs. A photograph of the patient wearing slim-fitting clothes can assist in the analysis of any postural misalignment. Also, attendees will learn to gather important data from patients, such as tracking basal body temperature in order to determine if weight gain is resulting from hormonal imbalance.







The use of oxygen by chiropractors has been an ongoing question. The State Board has requested information from the Board of Pharmacy. It is the State Board's understanding that medical gases, including those produced by the air liquefaction or processed, purified, or refined from a raw material, are prescription drugs according to the FDA. Therefore, a license is required by the Pharmacy Board and from the federal government when such gasses are classified as a legend drug and requiring a prescription. Additional information was received from the Board of Pharmacy indicating medical gasses bear the following federal legend "*for emergency use only when administered by properly trained personnel for oxygen deficiency and necessitation. For all other medical applications, RxOnly.*" If a chiropractor uses oxygen for emergency oxygen deficiency and resuscitation, it may be possible to distribute/refill a tank without a prescription.

Attached is a sample renewal form for the upcoming renewal cycle. Please note that the reduced renewal fee of \$100 is applicable only if the license is renewed prior to March 1, 2011.

The division is encouraging boards to move from a paper renewal format to online renewals. Online renewals reduce paper and postage as well as allow for the deposit of fees into the board's fund. Included with the renewal form is a sample post card recently used by the Board of Nursing. Instead of a renewal form being sent, a post card is mailed, directing the licensee to the web site to complete the renewal process online. If a licensee wants a paper renewal, s/he may mail, fax, or email a request and a paper form will be mailed out by the division's mail processing section.

During the last cycle approximately 24% of our licensees renewed on line. Boards such as nursing and appraisers have seen a significant increase in licenses being renewed earlier using the post card/online system. Therefore, the division is contacting all boards regarding postcard renewal notices.

Cleveland Chiropractic College's curriculum includes a course entitled Clinical Laboratory Diagnosis that covers all aspects of clinical diagnosis using laboratory methods, including indications for laboratory testing, interpretation of results and instruction in obtaining and handling samples. There is no lab for this class, however, students who are interested in learning the procedure of venipuncture have been directed to an elective course. As it happens, the elective course has not been scheduled for the past year or two having been discontinued due to lack of interest by students.

The Curriculum Committee is considering a proposal to once again offer the venipuncture elective. The potential course instructor has not been determined at this time, however, be assured that any instructor will have the necessary qualifications and credentials in compliance with accreditation requirements.

The 100-hour Meridian Therapy course is offered through the Postgraduate office of Cleveland Chiropractic College. Approximately 25% of the course time is devoted to lab-work where needling is taught (not all of the lab-work time is devoted to needling). The Course instructor teaches the clean needle technique where the student is taught when to needle and when not to needle. Safety methods of needling, moxibustion, the use of magnets, teishin and laser are also covered. When teaching the use of needles the forbidden points of acupuncture are covered; angle and depth recommendations are taught for each point. Gua Sha and cupping are also taught as modalities.

An estimate of time spent on each method is as follows:

Electric Acupuncture	10%	Acupatches	2%
Needle Acupuncture	5%	Gua Sha	1%
Moxibustion	2%	Magnets	1%
Teishin	2%	Cupping	1%
