



FINDINGS OF FACT

1. The Board is an agency of the state of Missouri created and established pursuant to § 329.015, RSMo,<sup>1</sup> for the purpose of licensing all persons engaged in the practice of barbering and cosmetology in this state. The Board has control and supervision of the licensed occupations and enforcement of the terms and provisions of Chapters 328 and 329, RSMo.

2. Jerry Bausby ("Applicant") is a natural person residing at 2201 Edmond, St. Joseph, Missouri 64501. [REDACTED]

3. On or about March 29, 2000, Applicant pled guilty in Jackson County Circuit Court, State of Missouri, case number 0516-CR01207-01, to one count of class B felony of Dist/Del/Man//Produce or Attempt To Or Possess W//Intent to Dist/Del/Man//Produce A Controlled Substance for which Applicant was sentenced to five years incarceration in the Missouri Department of Corrections.

4. On or about December 1, 2005, Applicant pled guilty in Jackson County Circuit Court, State of Missouri, case number 0516-CR06841-01, to two counts of class C felony of Domestic Assault - 2<sup>nd</sup> Degree for which Applicant was sentenced to five years incarceration in the Missouri Department of Corrections. Applicant also pled guilty to one count of the class A misdemeanor of Violation of Order of Protection for Adult for which Applicant was sentenced to 120 days incarceration in jail.

5. On or about May 6, 2009, Applicant pled guilty in Buchanan County Circuit Court, State of Missouri, case number 09BU-CR00731, to one count of class B

misdemeanor of DWI-Alcohol for which Applicant was sentenced to two days incarceration in jail.

6. On or about October 7, 2009, Applicant pled guilty in Buchanan County Circuit Court, State of Missouri, case number 09BU-CR01691, to one count of class A misdemeanor of Operated Motor Vehicle On Highway While Drivers License/Privilege Revoked for which Applicant was sentenced to 10 days incarceration in jail.

7. On or about July 12, 2010, Applicant pled guilty in Jackson County Circuit Court, State of Missouri, case number 1016-CR01147 to one count of class B misdemeanor of Dwi- Alcohol for which Applicant was sentenced to 120 days incarceration in jail, with execution of the sentence suspended and Applicant placed on two years of supervised probation. Applicant also pled guilty to one count of class A misdemeanor of Operator Motor Vehicle on Hwy While Driver License/Privilege Revoked for which Applicant was sentenced to 90 days incarceration in jail, with execution of the sentence suspended and Applicant placed on two years of supervised probation.

8. On or about May 6, 2011, Applicant filed a Student Enrollment Application with the Board seeking a cosmetology student license.

## II.

### CONCLUSIONS OF LAW

9. The Board has authority to deny or refuse a license application pursuant to § 329.140.1, RSMo 2000, which provides:

The board may refuse to issue any certificate of registration or authority, permit or license required pursuant to this chapter for one or any

combination of causes stated in subsection 2 of this section. The board shall notify the applicant in writing of the reasons for the refusal and shall advise the applicant of his right to file a complaint with the administrative hearing commission as provided by chapter 621, RSMo.

10. The Board has cause to deny or refuse Applicant's application for a cosmetology student license pursuant to § 329.140.2, RSMo, which provides:

The board may cause a complaint to be filed with the administrative hearing commission as provided by chapter 621, RSMo, against any holder of any certificate of registration or authority, permit or license required by this chapter or any person who has failed to renew or has surrendered the person's certificate of registration or authority, permit or license for any one or any combination of the following causes:

(2) The person has been finally adjudicated and found guilty, or entered a plea of guilty or nolo contendere, in a criminal prosecution under the laws of any state or of the United States, for any offense reasonably related to the qualifications, functions or duties of any profession licensed or regulated under this chapter, for any offense an essential element of which is fraud, dishonesty or an act of violence, or for any offense involving moral turpitude, whether or not sentence is imposed[.]

11. As a result of Applicant's actions as set forth in paragraphs 3 through 7 above, the Board has cause to deny or refuse Applicant's application for a cosmetology student license pursuant to § 329.140.1, RSMo, and § 329.140.2(2), RSMo.

12. As an alternative to refusing to issue a license, the Board may, at its discretion, issue a license subject to probation, pursuant to § 324.038.1, RSMo, which provides:

Whenever a board within or assigned to the division of professional registration, including the division itself when so empowered, may refuse to issue a license for reasons which also serve as a basis for filing a complaint with the administrative hearing commission seeking

disciplinary action against a holder of a license, the board, as an alternative to refusing to issue a license, may, at its discretion, issue to an applicant a license subject to probation.

13. The Board issues this Order in lieu of denial of Applicant's application for a cosmetology student license. The Board has determined that this Order is necessary to ensure the protection of the public.

### III.

#### ORDER

Based on the foregoing, Jerry Bausby is granted a cosmetology student license, which is hereby placed on PROBATION for the period during which he is enrolled in cosmetology school and receiving training hours, not to exceed five (5) years from the effective date of this Order. During the aforementioned probation, Jerry Bausby shall be entitled to enroll as a cosmetology student subject to the following terms and conditions.

### IV.

#### TERMS AND CONDITIONS

During the aforementioned probation, Jerry Bausby, Applicant, shall be entitled to enroll as a cosmetology student subject to the following terms and conditions:

- A. During the disciplinary period, Applicant shall comply with all provisions of Chapter 329, RSMo, all applicable board regulations, all applicable federal and state drug laws, rules and regulations and all applicable federal and state criminal laws. "State" includes the state of Missouri, all other states and territories of the United States, and the ordinances of their political subdivisions.
- B. During the disciplinary period, Applicant shall keep the Board informed of Applicant's current work and home telephone numbers. Applicant shall notify the Board in writing within ten days (10) of any change in this information.

- C. During the probationary period, Applicant shall timely renew Applicant's student license granted hereby and shall timely pay all fees required for licensure and comply with all other Board requirements necessary to maintain said license in a current and active state.
- D. During the probationary period, Applicant shall accept and comply with unannounced visits from the Board's representatives to monitor compliance with the terms and conditions of this Order.
- E. During the disciplinary period, Applicant shall appear in person for interviews with the Board or its designee upon request.
- F. Applicant shall submit written reports to the Board on or before January 1 and July 1 during each year of the probationary period stating truthfully whether there has been compliance with all terms and conditions of this Order. The first such report shall be received by the Board on or before January 1, 2012.
- G. If, at any time during the probationary period, Applicant changes Applicant's address from the state of Missouri, or ceases to maintain Applicant's cosmetology student license current or active under the provisions of Chapter 329, RSMo, or fails to keep the Board advised of all current places of residence, the time of such absence, unlicensed or inactive status, or unknown whereabouts shall not be deemed or taken to satisfy any part of the probationary period.
- H. The Board retains jurisdiction to hold a hearing at any time to determine if a violation of this Order has occurred and, if a violation of this Order has occurred, may seek to amend this Order or impose further disciplinary or appropriate action at the discretion of the Board. No order shall be entered by the Board pursuant to this paragraph without any required notice and opportunity for a hearing before the Board as provided by Chapter 536, RSMo.
- I. Unless otherwise specified by the Board, all reports, documentation, notices, or other materials required to be submitted to the Board shall be forwarded to: Missouri State Board of Cosmetology and Barber Examiners, P.O. Box 1062, Jefferson City, Missouri 65102.
- J. Any failure by Applicant to comply with any condition of discipline set forth herein constitutes a violation of this Order.

This Order does not bind the Board or restrict the remedies available to it concerning any violation by Applicant of the terms and conditions of this Order, Chapter 329, RSMo, or the regulations promulgated thereunder.

The Board will maintain this Order as an open, public record of the Board as provided in Chapters 329, 610, and 324, RSMo.
