**ORDER OF THE MISSOURI STATE BOARD OF
COSMETOLOGY AND BARBER EXAMINERS ISSUING A
PROBATIONARY COSMETOLOGY ESTABLISHMENT LICENSE TO
BEAUTY CAFE, NICOLE MADISON, OWNER**

The Missouri State Board of Cosmetology and Barber Examiners (hereafter, the “Board”) hereby issues its **ORDER** granting a **PROBATIONARY COSMETOLOGY ESTABLISHMENT LICENSE**, License No. 2012008672, to Beauty Café, Nicole Madison, owner (hereafter, “Licensee”), pursuant to the provisions of § 324.038, RSMo.¹ As set forth in § 324.038.2, RSMo, Licensee may submit a written request to the Administrative Hearing Commission seeking a hearing and review of the Board’s decision to issue a probated license. Such written request must be filed with the Administrative Hearing Commission within 30 days of delivery or mailing of this Order of the Board. The written request should be addressed to the Administrative Hearing Commission, P.O. Box 1557, Truman State Office Building, Room 640, Jefferson City, MO 65102-1557. If no written request for review is filed with the Administrative Hearing Commission within the 30-day period, the right to seek review of the Board’s decision shall be considered waived. Should Licensee file a written request for review of this Order, the terms and conditions of this Order shall remain in force and effect unless and/or until such time as the Administrative Hearing Commission issues an Order to the contrary.

Based upon the foregoing, the Board hereby states:

I.

FINDINGS OF FACT

1. The Board is an agency of the state of Missouri created and established pursuant to § 329.015, RSMo, for the purpose of licensing all persons engaged in the practice of barbering and cosmetology in this state. The Board has control and supervision of the licensed occupations and enforcement of the terms and provisions of Chapters 328 and 329, RSMo.

2. Licensee holds a cosmetology operator license issued by the Board, License no. 114774. Licensee's operator license was not at all times current and active. Licensee's operator license is now current and active as of January 11, 2012.

3. On or about January 25, 2012, Licensee filed an Application for Establishment Registration with the Board seeking licensure as a master, commercial cosmetology establishment under the name of Beauty Café, Nicole Madison, owner, to be located at 306 Rue Street, Florissant, Missouri 63031. Initial application was received April 8, 2011 and was rejected for additional documents.

4. On or about May 26, 2010, the Board inspected Beauty Cafe. The Board inspector discovered the following licensure issues: no establishment license for 306 Rue Street, Florissant, Missouri 63031 in violation of 20 CSR 2085-10.010 and cosmetology operator license for Nicole Madison not current in violation of 20 CSR 2085-7.040. A violation notice was sent June 28, 2010.

5. On or about July 15, 2010, the Board inspected Beauty Cafe. The Board inspector discovered the following licensure issues: no establishment license for 306 Rue Street,

Florissant, Missouri 63031 in violation of 20 CSR 2085-10.010 and cosmetology operator license for Nicole Madison not current in violation of 20 CSR 2085-7.040. A violation notice was sent September 23, 2010.

6. On or about October 29, 2010, the Board inspected Beauty Cafe. The Board inspector discovered the following licensure issues: no establishment license for 306 Rue Street, Florissant, Missouri 63031 in violation of 20 CSR 2085-10.010 and Brittanie McKeever was present and providing services without a Missouri cosmetology operator license in violation of 20 CSR 2085-10.060. A violation notice was sent January 27, 2011.

7. On or about February 17, 2011, the Board inspected Beauty Cafe. The Board inspector discovered the following licensure issues: no establishment license for 306 Rue Street, Florissant, Missouri 63031 in violation of 20 CSR 2085-10. A violation notice was sent June 28, 2010.

8. On or about November 3, 2011, the Board inspected Beauty Cafe. The Board inspector discovered the following licensure issues: no establishment license for 306 Rue Street, Florissant, Missouri 63031 in violation of 20 CSR 2085-10.010 and cosmetology operator license for Nicole Madison not current in violation of 20 CSR 2085-7.040.

CONCLUSIONS OF LAW

9. The Board has authority to deny or refuse a license application pursuant to § 329.140.1, RSMo 2000, which provides:

The board may refuse to issue any certificate of registration or authority, permit or license required pursuant to this chapter for one or any combination of causes stated in subsection 2 of this section. The board shall notify the applicant in writing of the reasons for the refusal and shall advise the applicant of the applicant's right to file a complaint with the administrative hearing commission as provided by chapter 621, RSMo.

10. As a result of the violations identified in paragraphs 3 and 8 herein, the Board has cause to deny or refuse Licensee's application for a cosmetology establishment license pursuant to § 329.140.2(6), RSMo, which provide:

2. The board may cause a complaint to be filed with the administrative hearing commission as provided by chapter 621, RSMo, against any holder of any certificate of registration or authority, permit or license required by this chapter or any person who has failed to renew or has surrendered the person's certificate of registration or authority, permit or license for any one or any combination of the following causes:

...

(6) Violation of, or assisting or enabling any person to violate, any provision of this chapter, or of any lawful rule or regulation adopted pursuant to this chapter.

11. As a result of the licensure violations set forth in paragraphs 3 and 8 herein, the Board has cause to deny Licensee's application for licensure pursuant to § 329.140.2(6), RSMo.

12. As an alternative to refusing to issue a license, the Board may, at its discretion, issue a license subject to probation, pursuant to § 324.038, RSMo 2000, which provides:

Whenever a board within or assigned to the division of professional registration, including the division itself when so empowered, may refuse to issue a license for reasons which also serve as a basis for filing a complaint with the administrative hearing commission seeking disciplinary action against a holder of license, the board, as an alternative to refusing to issue a license, may, at its discretion, issue to an applicant a license subject to probation.

13. The Board issues this Order in lieu of denial of Licensee's application for a cosmetology establishment license. The Board has determined that this Order is necessary to ensure the protection of the public.

III.

TERMS AND CONDITIONS

14. Based on the foregoing, Beauty Café, Nicole Madison, owner, is granted a cosmetology establishment license, which is hereby placed on **PROBATION** for a period of

THREE (3) YEARS from the effective date of this Order. During the aforementioned probation disciplinary period, Licensee shall be entitled to operate as a cosmetology establishment subject to the following terms and conditions:

- A. During the disciplinary period, Licensee shall comply with all provisions of Chapter 329, RSMo, all applicable board regulations, all applicable federal and state drug laws, rules and regulations and all applicable federal and state criminal laws. "State" includes the state of Missouri, all other states and territories of the United States, and the ordinances of their political subdivisions.
- B. During the disciplinary period, Licensee shall keep the Board informed of Licensee's current work and home telephone numbers. Licensee shall notify the Board in writing within ten days (10) of any change in this information.
- C. During the probationary period, Licensee shall timely renew Licensee's cosmetology establishment license granted hereby and shall timely pay all fees required for licensure and comply with all other Board requirements necessary to maintain said license in a current and active state.
- D. During the probationary period, Licensee shall accept and comply with unannounced visits from the Board's representatives to monitor compliance with the terms and conditions of this Order.
- E. During the probationary period, Licensee shall appear in person for interviews with the Board or its designee upon request.
- F. Licensee shall submit written reports to the Board on or before January 1 and July 1 during each year of the probationary period stating truthfully whether there has been compliance with all terms and conditions of this Order. The first such report shall be received by the Board on or before July 1, 2012.
- G. If, at any time during the probationary period, Licensee ceases to maintain Licensee's cosmetology establishment license current or active under the provisions of Chapter 329, RSMo, or fails to keep the Board advised of all current places of business and residence, the time of such absence, unlicensed or inactive status, or unknown whereabouts shall not be deemed or taken to satisfy any part of the probationary period.
- H. In the event the Board determines that Licensee has violated any term or condition of this Order, the Board may, in its discretion, pursue any lawful remedies or procedures afforded it and is not bound by this Order in its determination of appropriate legal actions or remedies concerning the allegations identified herein.

- I. The Board retains jurisdiction to hold a hearing at any time to determine if a violation of this Order has occurred and, if a violation of this Order has occurred, may seek to amend this Order or impose further disciplinary or appropriate action at the discretion of the Board. No order shall be entered by the Board pursuant to this paragraph without any required notice and opportunity for a hearing before the Board as required by Missouri law.
- J. Unless otherwise specified by the Board, all reports, documentation, notices, or other materials required to be submitted to the Board shall be forwarded to: Missouri State Board of Cosmetology and Barber Examiners, P.O. Box 1062, Jefferson City, Missouri 65102.
- K. Any failure by Licensee to comply with any condition of discipline set forth herein constitutes a violation of this Order.

15. This Order does not bind the Board or restrict the remedies available to it concerning any violation by Licensee of the terms and conditions of this Order, Chapters 329 or 324, RSMo, or the regulations promulgated thereunder.

16. The Board will maintain this Order as an open, public record of the Board as provided in Chapters 329, 610, and 324, RSMo.
