**ORDER OF THE
MISSOURI STATE BOARD OF COSMETOLOGY AND BARBER EXAMINERS
ISSUING A PROBATIONARY BARBER STUDENT LICENSE TO
DAMON GRIMES**

The Missouri State Board of Cosmetology and Barber Examiners (the "Board") hereby issues its **ORDER** granting a **PROBATIONARY BARBER STUDENT LICENSE**, No. 2003003884, to Damon Grimes (hereafter "Grimes"), pursuant to the provisions of § 324.038, RSMo. As set forth in § 324.038.2, RSMo, Grimes may submit a written request to the Administrative Hearing Commission seeking a hearing and review of the Board's decision to issue a probated license. Such written request must be filed with the Administrative Hearing Commission within 30 days of delivery or mailing of this Order of the Board. The written request should be addressed to the Administrative Hearing Commission, P.O. Box 1557, Truman State Office Building, Room 640, Jefferson City, MO 65102-1557. If no written request for review is filed with the Administrative Hearing Commission within the 30-day period, the right to seek review of the Board's decision shall be considered waived. Should Grimes file a written request for review of this Order, the terms and conditions of this Order shall remain in force and effect unless or until such time as the Administrative Hearing Commission issues an Order to the contrary.

Based upon the foregoing, the Board hereby states:

FINDINGS OF FACT

1. The Board is an agency of the state of Missouri created and established pursuant to § 329.015, RSMo,¹ for the purpose of licensing all persons engaged in the practice of barbering and cosmetology in this state. The Board has control and supervision of the licensed occupations and enforcement of the terms and provisions of Chapters 328 and 329, RSMo.

2. Damon Grimes ("Applicant") is a natural person residing at 8328 Fullerton, St. Louis, Missouri 63132.

3. On or about December 28, 2000, Applicant pled guilty in St. Louis County Circuit Court, State of Missouri, case number 2100R-03325-01, to the class C felony of Stealing- 3rd Offense. Applicant was sentenced to seven years incarceration, with execution of the sentence suspended, 120 days shock incarceration and Applicant placed on five years supervised probation. Applicant's probation was later revoked and on or about April 1, 2002, Applicant was ordered to serve his sentence of seven years incarceration.

4. On or about March 29, 2004, Applicant pled guilty in St. Louis County Circuit Court, State of Missouri, case number 2100R-03325-02, to the class C felony of Sealing - 3rd Offense for which Applicant was sentenced to five years incarceration in the Missouri Department of Corrections.

5. On or about March 24, 2006, Applicant pled guilty in St. Louis County Circuit Court, State of Missouri, case number 2105R-05300-01, to one count of a class C felony of Burglary - 2nd Degree and one count of a class B felony of Burglary -1st Degree. Applicant was sentenced to seven years incarceration in the Department of Corrections with execution of the

sentence suspended, 120 days of shock incarceration and Applicant placed on supervised probation. Applicant's probation was later revoked and on or about August 30, 2007, Applicant was ordered to serve his seven year sentence. On or about October 30, 2008, Applicant was released on three years supervised probation. Along with the March 24, 2006 guilty pleas referenced above, Applicant also pled guilty to one count of a Class B Misdemeanor of Unlawful Use of Drug Paraphernalia for which Applicant was sentenced to 60 days incarceration in jail.

6. On or about April 14, 2010, Applicant pled guilty in St. Louis County Circuit Court, State of Missouri, case number 09SL-CR05400-01, to one count of a class B felony of Robbery – 2nd Degree. Applicant was sentenced to seven years incarceration in the Missouri Department of Corrections with execution of the sentence suspended and Applicant placed on five years supervised probation.

7. On or about August 26, 2011, Applicant filed a Student Enrollment Application with the Board seeking a barber student license.

II.

CONCLUSIONS OF LAW

8. The Board has authority to deny or refuse a license application pursuant to § 328.150.1, RSMo 2000, which provides:

The board may refuse to issue any certificate of registration or authority, permit or license required pursuant to this chapter for one or any combination of causes stated in subsection 2 of this section. The board shall notify the applicant in writing of the reasons for the refusal and shall advise the applicant of his right to file a complaint with the administrative hearing commission as provided by chapter 621.

9. The Board has cause to deny or refuse Applicant's application for a barber student license pursuant to § 328.150.2, RSMo 2000, which provides:

The board may cause a complaint to be filed with the administrative hearing commission as provided by chapter 621 against any holder of any certificate of registration or authority, permit or license required by this chapter or any person who has failed to renew or has surrendered his certificate of registration or authority, permit or license for any one or any combination of the following causes: . . .

(2) The person has been finally adjudicated and found guilty, or entered a plea of guilty or nolo contendere, in a criminal prosecution under the laws of any state or of the United States, for any offense reasonably related to the qualifications, functions or duties of any profession licensed or regulated under this chapter, for any offense an essential element of which is fraud, dishonesty or an act of violence, or for any offense involving moral turpitude, whether or not sentence is imposed[.]

10. As a result of Applicant's convictions as set out in paragraph 3 through 6 above, the Board has cause to deny or refuse Applicant's application for a barber student license pursuant to § 328.150.1, RSMo, and § 328.150.2(2), RSMo.

11. As an alternative to refusing to issue a license, the Board may, at its discretion, issue a license subject to probation, pursuant to § 324.038.1, RSMo, which provides:

Whenever a board within or assigned to the division of professional registration, including the division itself when so empowered, may refuse to issue a license for reasons which also serve as a basis for filing a complaint with the administrative hearing commission seeking disciplinary action against a holder of a license, the board, as an alternative to refusing to issue a license, may, at its discretion, issue to an applicant a license subject to probation.

12. The Board issues this Order in lieu of denial of Applicant's application for a barber student license. The Board has determined that this Order is necessary to ensure the protection of the public.

III.

ORDER

Based on the foregoing, Damon Grimes is granted a barber student license, which is hereby placed on **PROBATION** for the period during which he is enrolled in barber school and receiving training hours, not to exceed five (5) years from the effective date of this Order.

During the aforementioned probation, Damon Grimes shall be entitled to enroll as a barber student subject to the following terms and conditions:

IV.

TERMS AND CONDITIONS

During the aforementioned probation, Damon Grimes, Applicant, shall be entitled to present himself and serve as a licensed barber student subject to the following terms and conditions:

- A. During the disciplinary period, Applicant shall comply with all provisions of Chapter 328, RSMo (as amended), all applicable board regulations, all applicable federal and state drug laws, rules and regulations and all applicable federal and state criminal laws. "State" includes the state of Missouri, all other states and territories of the United States, and the ordinances of their political subdivisions.
- B. During the disciplinary period, Applicant shall keep the Board informed of Applicant current work and home telephone numbers. Applicant shall notify the Board in writing within ten days (10) of any change in this information.
- C. During the probationary period, Applicant shall timely renew Applicant's student license granted hereby and shall timely pay all fees required for licensure and comply with all other Board requirements necessary to maintain said license in a current and active state.
- D. During the probationary period, Applicant shall accept and comply with unannounced visits from the Board's representatives to monitor compliance with the terms and conditions of this Order.
- E. During the disciplinary period, Applicant shall appear in person for interviews with the Board or its designee upon request.
- F. Applicant shall submit written reports to the Board on or before January 1 and July 1 during each year of the probationary period stating truthfully whether there has been compliance with all terms and conditions of this Order. The first such report shall be received by the Board on or before January 1, 2012.
- G. If, at any time during the probationary period, Applicant changes Applicant's address from the state of Missouri, or ceases to maintain Applicant's barber student license current or active under the provisions of Chapter 328, RSMo (as amended), or fails to keep the Board advised of all current places of residence, the time of such absence, unlicensed or inactive status, or unknown whereabouts shall not be deemed or taken to satisfy any part of the probationary period.


- H. The Board retains jurisdiction to hold a hearing at any time to determine if a violation of this Order has occurred and, if a violation of this Order has occurred, may seek to amend this Order or impose further disciplinary or appropriate action at the discretion of the Board. No order shall be entered by the Board pursuant to this paragraph without any required notice and opportunity for a hearing before the Board as provided by Chapter 536, RSMo (as amended).
- I. Unless otherwise specified by the Board, all reports, documentation, notices, or other materials required to be submitted to the Board shall be forwarded to: Missouri State Board of Cosmetology and Barber Examiners, P.O. Box 1062, Jefferson City, Missouri 65102.
- J. Any failure by Applicant to comply with any condition of discipline set forth herein constitutes a violation of this Order.

This Order does not bind the Board or restrict the remedies available to it concerning any violation by Respondent of the terms and conditions of this Order, Chapters 324, 328 and 329, RSMo, or the regulations promulgated thereunder.

The Board will maintain this Order as an open, public record of the Board as provided in Chapters 328, 329, 610, and 324, RSMo.
