**FINDINGS OF FACT, CONCLUSIONS  
OF LAW, AND DISCIPLINARY ORDER**

On or about May 26, 2015, the Administrative Hearing Commission entered its Decision in the case of *Missouri Board of Cosmetology and Barber Examiners v. Walter Parsons*, Case No. 14-0588 CB. In that Decision, the Administrative Hearing Commission found that Respondent Walter Parson's "Class CA -hairdressing and manicuring" operator license (license # 080196) is subject to disciplinary action by the Missouri Board Cosmetology and Barber Examiners ("Board") pursuant to § 329.140.2(2), RSMo.<sup>1</sup>

The Board has received and reviewed the record of the proceedings before the Administrative Hearing Commission, including the properly pled complaint filed before the Administrative Hearing Commission on May 6, 2014 and the Decision of the Administrative Hearing Commission. The record of the Administrative Hearing Commission, including the properly pled complaint and Decision, is incorporated herein by reference in its entirety.

Pursuant to notice and § 621.110 and § 329.140.3, RSMo, the Board scheduled a hearing to be held on September 14, 2015, at approximately 9:00 a.m. at the Main Conference Meeting Room at the Division of Professional Registration Building, 3605 Missouri Boulevard, Jefferson City, Missouri 65109, for the purpose of determining the appropriate disciplinary action against Parson's

license. At the September 14, 2015 disciplinary hearing, the Board was represented by attorney Diana Carter. Respondent and his legal counsel, Robert Parson, Jr., appeared via telephone. After being present and considering all of the evidence presented during the hearing, the Board issues the following Findings of Facts, Conclusions of Law and Order

Based upon the foregoing the Board hereby states:

I.

**FINDINGS OF FACT**

1. The Board is an agency of the state of Missouri created and established pursuant to § 329.015, RSMo, for the purpose of licensing all persons engaged in the practice of barbering and cosmetology in this state. The Board has control and supervision of the licensed occupations and enforcement of the terms and provisions of Chapters 328 and 329, RSMo.

2. Respondent holds a "Class CA -hairdressing and manicuring" license (license # 080196). Respondent's license was at all times, relevant to the Complaint filed, was current and active.

3. The Board hereby adopts and incorporates by reference the properly pled complaint and Decision of the Administrative Hearing Commission in *Missouri Board of Cosmetology and Barber Examiners v. Walter Parson*, Case No. 14-0588 CB, in its entirety. In that Decision the Administrative Hearing Commission determined that the Board filed a properly pled complaint before the Administrative Hearing Commission on or about May 6, 2014, that Respondent was served with the complaint by certified mail and Respondent filed an answer on September 12, 2014. The parties filed a Joint Statement of Facts with the Administrative Hearing Commission on May 13, 2014. The Administrative Hearing Commission held a hearing on the Complaint on May 15, 2015.

4. In its Decision, the Administrative Hearing Commission determined there was cause to discipline Respondent's licenses pursuant to § 329.140.2(2), RSMo, as established in the properly

pled complaint, as a result of Respondent's March 12, 2012 guilty plea in the Circuit Court of St. Louis County, Missouri to the unclassified felony of attempted forcible rape, attempted sexual intercourse by forcible compulsion, the class A misdemeanor of sexual misconduct in the first degree, the class C misdemeanor of assault in the third degree and the class B misdemeanor of sexual misconduct. Respondent was sentenced to five years' incarceration on the charge of attempted forcible rape, fifteen days' incarceration on the charge of assault, and six months' incarceration on the class B charge of sexual misconduct.

5. The Board set this matter for disciplinary hearing and served notice of the disciplinary hearing upon Respondent in a proper and timely fashion.

## II.

### CONCLUSIONS OF LAW

---

6. This Board has jurisdiction over this proceeding pursuant to §§ 621.110 and 329.140.3, RSMo.

7. The Board expressly adopts and incorporates by reference the properly pled complaint and the Decision issued by the Administrative Hearing Commission on May 26, 2015, in *Missouri Board of Cosmetology and Barber Examiners v. Walter Parson*, Case No. 14-0588 CB, and hereby enters its Conclusions of Law consistent therewith.

8. As a result of the foregoing, and in accordance with the Administrative Hearing Commission's Decision on May 26, 2015, Respondent's "Class CA -hairdressing and manicuring" license (license # 080196) is subject to disciplinary subject to disciplinary action by the Board pursuant to § 329.140.2(2), RSMo.

9. The Board has determined that this Order is necessary to ensure the protection of the public.

III.

ORDER

Having fully considered all the evidence before the Board, and giving full weight to the Decision of the Administrative Hearing Commission, it is the ORDER of the Board that Respondent's "Class CA -hairdressing and manicuring" license (license # 080196) shall immediately be placed on PROBATION for a period of three (3) years ("probationary period"), subject to the following terms and conditions.

IV.

TERMS AND CONDITIONS

During the aforementioned probation, Walter Parson shall be entitled to perform cosmetologist services as a licensed "Class CA -hairdressing and manicuring" subject to the following terms and conditions:

- A. During the probationary period Respondent shall comply with all provisions of Chapter 329, RSMo, all applicable board regulations, all applicable federal and state drug laws, rules and regulations and all applicable federal and state criminal laws. "State" includes the state of Missouri, all other states and territories of the United States, and the ordinances of their political subdivisions.
- B. During the probationary period, Respondent shall keep the Board informed of Respondent's current telephone number and address. Respondent shall notify the Board in writing within ten days (10) of any change in this information.
- C. During the probationary period, Respondent shall timely renew Respondent's license and shall timely pay all fees required for licensure and comply with all other Board requirements necessary to maintain said licenses in a current and active state.
- D. During the probationary period, Respondent shall accept and comply with unannounced visits from the Board's representatives to monitor compliance with the terms and conditions of this Order.
- E. During the probationary period, Respondent shall appear in person for interviews with the Board or its designee upon request.
- F. During the probationary period, Respondent shall submit written reports to the Board on or before January 1 and July 1 during each year of the probationary period stating truthfully whether there has been compliance with all terms and conditions of this Order. The first such report shall be received by the Board on or before January 1, 2016.

- G. If, at any time during the probationary period, Respondent changes Respondent's address from the state of Missouri, or ceases to maintain Respondent's license as current or active under the provisions of Chapter 329, RSMo, or fails to keep the Board advised of all current places of residence, the time of such absence, unlicensed or inactive status, or unknown whereabouts shall not be deemed or taken to satisfy any part of the probationary period.
- H. Upon expiration of the probationary period, Respondent's license shall be fully restored if all requirements of the law have been satisfied; provided, however, that in the event the Board determines that Licensee has violated any term or condition of this Order, the Board may, in its discretion, pursue any lawful remedies or procedures afforded it and is not bound by this Order in its determination of appropriate legal actions or remedies concerning the allegations identified herein.
- I. The Board retains jurisdiction to hold a hearing at any time to determine if a violation of this Order has occurred and, if a violation of this Order has occurred, may seek to amend this Order or impose further disciplinary or appropriate action at the discretion of the Board. No order shall be entered by the Board pursuant to this paragraph without any required notice and opportunity for a hearing before the Board as provided by Chapter 536, RSMo.
- J. Unless otherwise specified by the Board, all reports, documentation, notices, or other materials required to be submitted to the Board shall be forwarded to: Missouri State Board of Cosmetology and Barber Examiners, P.O. Box 1062, Jefferson City, Missouri 65102.
- K. Any failure by Respondent to comply with any condition of discipline set forth herein constitutes a violation of this Order.

The Board will maintain this Order as an open and public record of the Board as provided in Chapters 329, 610, and 324, RSMo.
