

3. As of July 2, 2015, Defendant owed past due support of \$16,73.00.

4. Thus, Defendant owes an arrearage in an amount greater than or equal to three months support payments or two thousand five hundred dollars.

5. On September 12, 2015, the Division served Defendant at 8150 Prairie View Road, Kansas City, Missouri with a Petition to Suspend Professional License and a Notice of Intent to Suspend Professional License.

6. The Notice of Intent stated that Defendants' barber license #, #2014003019 shall be suspended within sixty (60) days of service of the Notice of Intent unless Defendant: (1) paid the entire arrearage stated in the Notice of Intent; or (2) entered into and complied with a payment plan approved by this Court; or (3) requested a hearing before this Court.

7. As of November 16, 2015, Defendant has not paid the entire arrearage, has not requested a hearing, nor entered into and complied with a payment plan.

8. Thus, Defendants' defenses and objections shall be considered to be without merit and this Court may enter an order suspending the obligor's license and ordering the obligor to refrain from engaging in the licensed activity. § 454.1005.2, RSMo.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that suspension of Defendants' cosmetology license, License Number #2014003019 is suspended. Defendant shall refrain from engaging in this licensed activity.

2. Enter the suspension of Defendants license as effective from the date of this Order Suspending License;
3. Issue a Notice of Suspension to Defendant; and
4. If required by law, demand surrender of the suspended license.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Missouri Division of Professional Registration and the Board of Barbers and Cosmetology and Barber Examiners process this order without conducting an additional hearing or review.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that this Courts order suspending Defendants license shall be implemented by the Missouri Division of Professional Registration and the Board of Barbers and Cosmetology and Barber Examiners and shall continue until they receive notice from this Court that this suspension has been stayed or terminated.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that any funds paid by the Defendant to the Missouri Division of Professional Registration and the Board of Cosmetology and Barber Examiners for costs related to issuance, renewal or maintenance of a license shall not be refunded to Defendant.


