**ORDER OF THE MISSOURI STATE BOARD OF COSMETOLOGY
AND BARBER EXAMINERS ISSUING A PROBATIONARY
COSMETOLOGY STUDENT LICENSE TO BRANDEE R. YOUNG**

The Missouri State Board of Cosmetology and Barber Examiners (the "Board") hereby issues its **ORDER** granting a **PROBATIONARY COSMETOLOGY STUDENT LICENSE**, License No. 2015035294 to Brandee Young ("Young" or "Applicant"), pursuant to the provisions of § 324.038, RSMo.¹ As set forth in § 324.038.2, RSMo, Young may submit a written request to the Administrative Hearing Commission seeking a hearing and review of the Board's decision to issue a probated student license. Such written request must be filed with the Administrative Hearing Commission within 30 days of delivery or mailing of this Order of the Board. The written request should be addressed to the Administrative Hearing Commission, P.O. Box 1557, Truman State Office Building, Room 640, Jefferson City, MO 65102-1557. If no written request for review is filed with the Administrative Hearing Commission within the 30-day period, the right to seek review of the Board's decision shall be considered waived. Should Young file a written request for review of this Order, the terms and conditions of this Order shall remain in force and effect unless and/or until such time as the Administrative Hearing Commission issues an Order to the contrary.

Based upon the foregoing, the Board hereby states:

I.

FINDINGS OF FACT

1. The Board is an agency of the state of Missouri created and established pursuant to § 329.015, RSMo, for the purpose of licensing all persons engaged in the practice of barbering and cosmetology in this state. The Board has control and supervision of the licensed occupations and enforcement of the terms and provisions of Chapters 328 and 329, RSMo.

2. On or about May 26, 2015, Young applied for a Missouri cosmetology student license to enroll at Vandalia Institute of Cosmetology, 1101 E. Hwy. 54, Vandalia, Missouri.

3. On her application, Young answered "yes" to the question "Have you been adjudicated and found guilty, or entered a plea of guilty or nolo contendere, in a criminal prosecution in this state, or any or of the United States, whether or not sentence was imposed?"

4. In conjunction with her May 26, 2014 application, Young provided an explanation of her criminal history. In her explanation, Young stated that her most recent convictions have been for non-violent felonies of forgery and the passing of bad checks.

5. A review of Young's Missouri criminal history reveals that:

a. on or about, April 3, 2000, Young pled guilty to the class A misdemeanor of *Possession Of Up To 35 Grams Marijuana*, in the Circuit Court of Cape Girardeau, County, Missouri, case number 32R050000274. The Court sentenced Young to a fine.

b. on or about, December 12, 2000, Young pled guilty to the class A misdemeanor of *Oper Mtr Veh On Hwy While Driver License/Privilege Revkd (Revkd For Points/Fail To Submit To Chem Test)* and the class C misdemeanor of *As Owner, Oper Or Auth Another To Oper A Mtr Veh W/Out Maintain Financial Respons (Mtr Veh Reqr To Be Reg)*, in the Circuit Court of Cape Girardeau, County, Missouri, case number 32R050001597.

The Court sentenced 90 days jail incarceration with the suspension of the execution of sentence. Young was placed on supervised probation with required adherence to specific conditions for the class A misdemeanor and issued a fine for the class C misdemeanor.

c. on or about, May 21, 2001, Young was found guilty of the class A misdemeanor of *Oper Mtr Veh On Hwy While Driver License/Privilege Revkd (Suspended For Points)*, in the Circuit Court of Cape Girardeau, County, Missouri, case number 32R050100456. The Court sentenced Young to 90 days jail incarceration with the suspension of the execution of sentence. Young was placed in shock incarceration for 14 days and given 2 years' supervised probation followed by 1 year of unsupervised probation.

d. on or about, March 27, 2006, Young pled guilty of the class C felony of *Forgery*, in the Circuit Court of Cape Girardeau, County, Missouri, case number 06G9-CR00062-01. The Court sentenced Young to 4 years' incarceration with the Missouri Department of Corrections.

e. on or about, September 11, 2006, Young pled guilty of the class A misdemeanor of *Resisting/Interfering With Arrest, Detention Or Stop*, in the Circuit Court of Cape Girardeau, County, Missouri, case number 06G9-CR01535-01. The Court sentenced Young to 50 days jail incarceration.

f. on or about, September 11, 2006, Young pled guilty of the class C felony of *Passing Bad Check - \$500 Or More - No Account/Insufficient Funds*, in the Circuit Court of Cape Girardeau, County, Missouri, case number 08G9-CR00257. The Court sentenced Young to 4 years' incarceration in the Missouri Department of Corrections.

g. on or about, February 27, 2008, Young pled guilty of the class A misdemeanor of *Unlawful Use Of Drug Paraphernalia*, in the Circuit Court of Cape Girardeau, County, Missouri, case number 08G9-CR00087. The Court sentenced Young to 60 days jail incarceration.

h. on or about, November 23, 2009, Young pled guilty of the class D felony of *Resisting Arrest/Detention/Stop By Fleeing – Creating A Substantial Risk Of Serious Injury/Death To Any Person*, in the Circuit Court of Cape Girardeau, County, Missouri, case number 09G9-CR02036-01. The Court sentenced Young to 1 year of jail incarceration to run concurrently with any other sentence which Young was serving.

i. on or about, January 24, 2011, Young pled guilty of the class A misdemeanor of *Operate Motor Vehicle On Hwy While Driver Lic/Privilege Revoked (Suspend For Nonappear/Nonpayment Of Court Fine/Costs)*, in the Circuit Court of Cape Girardeau, County, Missouri, case number 10CG-CR02296. The Court sentenced Young to 30 days jail incarceration, allowing for time served.

j. on or about, June 7, 2011, Young pled guilty of the class A misdemeanor of *Operated Motor Vehicle On Hwy While Driver License/Privilege Revoked (Canceled/Suspended/Revoked For Unknown Reasons)* and the class A misdemeanor of *Failed To Comply With Court Order Requiring Use Of Ignition Interlock Device – 1st Offense*, in the Circuit Court of Cape Girardeau, County, Missouri, case number 11CG-CR00826. The Court sentenced Young to 45 days jail incarceration, on each count, concurrent.

k. on or about, February 11, 2013, Young pled guilty of the class A misdemeanor of *Receiving Stolen Property*, in the Circuit Court of Cape Girardeau, County, Missouri, case number 12CG-CR01209. The Court sentenced Young to 45 days jail incarceration.

l. on or about, July 8, 2014, Young pled guilty of the class A misdemeanor of *Passing Bad Check – Less Than \$500*, in the Circuit Court of Cape Girardeau, County, Missouri, case number 14CG-CR00421. The Court sentenced Young to 30 days jail incarceration.

m. on or about, October 27, 2014, Young pled guilty of two charges of the class C felony of *Forgery*, in the Circuit Court of Cape Girardeau, County, Missouri, case number 14CG-CR00219-01. The Court sentenced Young to 7 years' incarceration on each count to run concurrent with each other and to run concurrent with case number 14CG-CR01063-01.

n. on or about, October 27, 2014, Young pled guilty of two charges of the class C felony of *Forgery*, in the Circuit Court of Cape Girardeau, County, Missouri, case number 14CG-CR01063-01. The Court sentenced Young to 7 years' DOC incarceration on each count to run concurrent with each other and to run concurrent with case number 14CG-CR00219-01.

o. on or about, February 20, 2015, Young pled guilty to the class C felony of *Forgery*, in the Circuit Court of St. Francois, County, Missouri, case number 14SF-CR00197-01. The Court sentenced Young to 5 years' DOC incarceration to run concurrent to any sentence Young was obligated to serve.

p. on or about, March 18, 2015, Young pled guilty to the unclassified misdemeanor of *Driving While Revoked/Suspended – 1st Offense*, and subsequently amended to a

misdemeanor *Driving Revoked*, in the Circuit Court of Bollinger, County, Missouri, case number 13BO-CR00357. The Court sentenced Young to 6 months jail incarceration.

II.

CONCLUSIONS OF LAW

6. The Board has authority to deny or refuse a license application pursuant to § 329.140.1, RSMo, which provides:

The board may refuse to issue any certificate of registration or authority, permit or license required pursuant to this chapter for one or any combination of causes stated in subsection 2 of this section. The board shall notify the applicant in writing of the reasons for the refusal and shall advise the applicant of his right to file a complaint with the administrative hearing commission as provided by chapter 621, RSMo.

~~7. The Board has cause to deny or refuse Young's application for a cosmetology student license pursuant to § 329.140.2, RSMo, which provides:~~

The board may cause a complaint to be filed with the administrative hearing commission as provided by chapter 621, RSMo, against any holder of any certificate of registration or authority, permit or license required by this chapter or any person who has failed to renew or has surrendered the person's certificate of registration or authority, permit or license for any one or any combination of the following causes:

...

(2) The person has been finally adjudicated and found guilty, or entered a plea of guilty or nolo contendere, in a criminal prosecution under the laws of any state or of the United States, for any offense reasonably related to the qualifications, functions or duties of any profession licensed or regulated under this chapter, for any offense an essential element of which is fraud, dishonesty or an act of violence, or for any offense involving moral turpitude, whether or not sentence is imposed[.]

8. As a result of Young's criminal prosecutions as detailed in paragraph 5 above, the Board has cause to deny or refuse Young's application for a cosmetology student license pursuant to § 329.140.1, RSMo, and § 329.140.2(2), RSMo.

9. As an alternative to refusing to issue a license, the Board may, at its discretion, issue a license subject to probation, pursuant to § 324.038, RSMo, which provides:

Whenever a board within or assigned to the division of professional registration, including the division itself when so empowered, may refuse to issue a license for reasons which also serve as a basis for filing a complaint with the administrative hearing commission seeking disciplinary action against a holder of a license, the board, as an alternative to refusing to issue a license, may, at its discretion, issue to an applicant a license subject to probation.

10. The Board issues this Order in lieu of denial of Young's application for a cosmetology student license. The Board has determined that this Order is necessary to ensure the protection of the public.

III.

ORDER

11. Based on the foregoing, Brandee R. Young is granted a cosmetology **student license**, which is hereby placed on **PROBATION** for the period during which she is enrolled in cosmetology school and receiving training hours, not to exceed five (5) years from the effective date of this Order. During the aforementioned probation, Brandee R. Young shall be entitled to enroll as a cosmetology student subject to the following terms and conditions.

IV.

TERMS AND CONDITIONS

12. During the aforementioned probation, Brandee R. Young, shall be entitled to enroll as a cosmetology student subject to the following terms and conditions:

- A. During the disciplinary period, Applicant shall comply with all provisions of Chapter 329, RSMo, all applicable board regulations, all applicable federal and state drug laws, rules and regulations and all applicable federal and state criminal laws. "State" includes the state of Missouri, all other states and territories of the United States, and the ordinances of their political subdivisions.

- B. During the disciplinary period, Applicant shall keep the Board informed of Applicant's current work and home telephone numbers. Applicant shall notify the Board in writing within ten days (10) of any change in this information.
 - C. During the probationary period, Applicant shall timely renew Applicant's student license granted hereby and shall timely pay all fees required for licensure and comply with all other Board requirements necessary to maintain said license in a current and active state.
 - D. During the probationary period, Applicant shall accept and comply with unannounced visits from the Board's representatives to monitor compliance with the terms and conditions of this Order.
 - E. During the disciplinary period, Applicant shall appear in person for interviews with the Board or its designee upon request.
 - F. Applicant shall submit written reports to the Board on or before January 1 and July 1 during each year of the probationary period stating truthfully whether there has been compliance with all terms and conditions of this Order. The first such report shall be received by the Board on or before January 1, 2016.

- G. If, at any time during the probationary period, Applicant changes Applicant's address from the state of Missouri, or ceases to maintain Applicant's student license current or active under the provisions of Chapter 329, RSMo, or fails to keep the Board advised of all current places of residence, the time of such absence, unlicensed or inactive status, or unknown whereabouts shall not be deemed or taken to satisfy any part of the probationary period.
 - H. The Board retains jurisdiction to hold a hearing at any time to determine if a violation of this Order has occurred and, if a violation of this Order has occurred, may seek to amend this Order or impose further disciplinary or appropriate action at the discretion of the Board. No order shall be entered by the Board pursuant to this paragraph without any required notice and opportunity for a hearing before the Board as provided by Chapter 536, RSMo.
 - I. Unless otherwise specified by the Board, all reports, documentation, notices, or other materials required to be submitted to the Board shall be forwarded to: Missouri State Board of Cosmetology and Barber Examiners, P.O. Box 1062, Jefferson City, Missouri 65102.
 - J. Any failure by Applicant to comply with any condition of discipline set forth herein constitutes a violation of this Order.

13. This Order does not bind the Board or restrict the remedies available to it concerning any violation by Applicant of the terms and conditions of this Order, Chapter 329, RSMo, or the regulations promulgated thereunder.

14. The Board will maintain this Order as an open, public record of the Board as provided in Chapters 329, 610 and 324, RSMo.
