If your operator and/or establishment license(s) expired September 30, 2015 please complete these steps prior to September 30, 2017.

- Visit <http://pr.mo.gov/cosbar-forms.asp> and select the applicable reinstatement application under "REINSTATEMENT APPLICATIONS".
- Complete the application and submit via mail to the Board office with the applicable fee as listed on the reinstatement application.
- The Board office will review the application for eligibility and process the reinstatement of the license. Should there be any deficiencies to allow for processing, notification will be sent in writing to the address listed on the reinstatement application.

If your instructor license expired September 30, 2015 please complete these steps prior to September 30, 2017.

- Visit <http://pr.mo.gov/cosbar-forms.asp> and select the applicable reinstatement application under "REINSTATEMENT APPLICATIONS".
- Complete the application and submit via mail to the Board office with the applicable fee as listed on the reinstatement application and (COSMETOLOGY AND CROSSOVER ONLY) proof of attendance within two (2) years of date of application at an instructor training seminar approved by the Board.
- The Board office will review the application for eligibility and process the reinstatement of the license. Should there be any deficiencies to allow for processing, notification will be sent in writing to the address listed on the reinstatement application.
