APPROVAL OF AGENDA

A motion was made by Ms. Lepp and seconded by Dr. Christman that the agenda be approved as published. Motion carried unanimously.

REED DENTAL SEMINARS ON SEDATION

The Board reviewed the program materials received from Dr. Michael Hoffmann with regard to the Reed Dental Seminars on Sedation and considered approval of the program as meeting the requirements for an enteral conscious sedation permit under the new rules. Dr. Hoffmann advised the Board that the program meets and exceeds the requirements for an enteral conscious sedation permit under the new rules. It is a three (3) day, twenty-one (21) hour course for both the dentist and their assistants. Dr. Hoffmann reported, however, that the program will not be held in May as originally thought. It is now likely to be held sometime in July but it will still be in St. Louis. Dr. Hoffmann also reported that the enteral conscious sedation course being sponsored by the American Dental Society of Anesthesiology (ADSA) will be held during the Mid-Continent meeting on September 15-17, 2005. This course was previously approved by the Board on a mail ballot. A motion was made by Ms. Lepp and seconded by Dr. Christman that the Board approve the enteral conscious sedation course sponsored by the Reed Dental Seminars on Sedation for meeting the educational qualifications for an enteral conscious sedation permit under the new rules. Those voting yes: Dr. Christman, Dr. Sheets, Dr. Aubert, Ms. Lepp, and Ms. Thompson. Motion carried 5 to 0. Dr. Jackson was not present for the vote.

CLOSED SESSION

A motion was made by Dr. Sheets and seconded by Dr. Christman to move into closed session pursuant to section 610.021 (1) and (3) and section 620.010.14 (7) RSMo, for the purpose of discussing general legal actions, causes of action or litigation and any confidential or privileged communications between the Board and its attorney and investigative reports and/or complaints. Those voting yes: Ms. Thompson, Ms. Lepp, Dr. Aubert, Dr. Sheets, and Dr. Christman. Motion carried 5 to 0. Dr. Jackson was not present for the vote.

There being no further business to be brought before the Board at this time, a motion was made by Ms. Thompson and seconded by Dr. Sheets that this meeting adjourn. Motion carried unanimously. The meeting adjourned at approximately 10:38 p.m.
