APPROVAL OF THE AGENDA

Mr. Barnett requested that an item be added to the agenda to schedule a meeting to discuss the changes that will need to be made to the Dental Assistants rule. Ms. Lepp requested that an item be added to the agenda to discuss the CRDTS annual meeting. A motion was made by Ms. Lepp and seconded by Dr. Aubert to approve the open agenda as amended. The motion carried unanimously.

FUTURE MEETING TO DISCUSS CHANGES TO THE DENTAL ASSISTANTS RULE

Mr. Barnett requested that an item be included on the July open meeting agenda to schedule a date to discuss the changes that will need to be made to the Dental Assistants rule as a result of the recent statute change. Mr. Barnett would like the Board to schedule a separate meeting to dedicate to this item. Dr. Wallace requested that an item be added to the July agenda to discuss mobile dentistry. Mr. Barnett informed the Board that he would prepare a draft of the changes needed for the Dental

Assistants rule, and include it on the July meeting agenda along with the mobile dentistry topic.
