The Junior College District of St. Louis

Practical Nursing Programs Closing

We are sorry to report that three practical nursing programs in Missouri are closing. These are:

- (1) Community School of Practical Nursing, St. Louis, Missouri
- (2) Mercy School of Practical Nursing, Springfield, Missouri
- (3) Northwest District Public School Program of Practical Nursing, Excelsior Springs, Missouri

Procedure for Reporting Violations of Nurse Practice Act

(1) Anyone who wishes to report a violation of the Missouri Nurse Practice Act, by a professional nurse or one claiming to be a professional nurse, should send a letter giving the facts regarding the case to the Missouri State Nurses' Association, Committee on *Professional Standards*, 206 E. Dunklin, Jefferson City, Mo. The association will in turn send the data to the Missouri State Board of Nursing for investigation.

(2) One may also write directly to the Missouri State Board of Nursing regarding violations of the Missouri Nurse Practice Act. The letter should contain the facts regarding the case.

(3) Phone calls or oral statements cannot be accepted as reports.

(4) The Missouri State Board of Nursing will investigate regarding the charges and attempt to obtain notarized statements regarding the violation.

ANA Notice

The following memorandum is brought to your attention from the ANA:

"The Department of State has been in contact with the Phil-Am Travel Agency, San Francisco, which has circularized many hospitals throughout the country offering to bring in "qualified graduate nurses from the Philippines under a two to three year work contract". The State Department has indicated to this agency that the basic purpose of the Exchange Program is educational in nature, and that it is not designed and should not be used to alleviate staffing shortage in hospitals here.

The Immigration and Naturalization Service has reaffirmed that the only way a foreign nurse may enter the United States on a temporary basis is as an exchange visitor, that is, as a participant in a program in an agency or institution designated by the Department of State to conduct an exchange visitor program for nurses. The Immigration and Naturalization Service has informed us that they do not recognize travel agents as

authorized representatives of applicants or petitioners seeking benefits under the Immigration and Naturalization Laws of the United States."

Statistics on Nursing Education Regarding Registered Nurses

Baccalaureate Degrees

(1) For the second year there has been a decrease in the number of registered nurses graduating from baccalaureate programs in nursing. Those graduating with degrees in a functional specialization have decreased greatly over the years from 814 in 1952-1953 to 88 in 1961-1962. However, the number preparing for initial professional practice has increased from 1,152 in 1952-1953 to 2,265 in 1961-1962.

(2) It is of interest to note that registered nurses are selecting programs for study with an upper division major in nursing, with nursing faculty, and with an accreditation status.

Masters Degrees

- (1) Graduations from masters degree programs (1,098) in 1961-1962 continue to increase but are still below the 1959-1960 figures.
- (2) Those graduating with a masters degree in administration, supervision, teaching, or consultation in 1961-1962 totaled 979 nurses.
- (3) The field of nursing most frequently selected was medical-surgical nursing with 341 graduates in 1961-1962.
- (4) Total enrollments in master's programs (2,472) in 1962-1963 continue to increase but are below the 1958-1959 figures.
- (5) Of those enrolled in 1962-1963, the functional area most frequently selected was teaching with a total of 1,303 students.
- (6) Those who enrolled in masters programs in 1962-1963 selected the medical-surgical area most frequently for their advanced study making a total of 957 students.

Doctoral Degree Programs

- (1) The number of doctoral programs in nursing is four.
- (2) Full-time enrollment has decreased from 73, which was the high in 1959-1960, to 64 in 1962-1963.
- (3) Part-time enrollment has increased steadily from 26 in 1954-1955 to 80 in 1962-1963.
- (4) Graduations have increased to 13 in 1961-1962.
