DISCIPLINARY PROBLEMS CONSIDERED BY BOARD

At the January, May, and July, 1977 meetings, the Board considered:

1. Ten (10) cases involving applicants who had arrest records prior to granting permission to write the State Board Test Pool Examination for professional nurse licensure; and four (4) practical nurse applications.
2. Twelve (12) complaints received by the Board against registered professional nurses and five (5) against licensed practical nurses.
3. Referred fifteen (15) cases to the Administrative Hearing Commission (hearings pending.)
4. Denied three (3) applicants for registered professional nurse licensure and three (3) applicants for practical nurse licensure by reciprocity (did not meet Missouri's Minimum Education Requirements).
5. Conducted five (5) hearings to determine disciplinary action.
6. Suspended one (1) practical nurse license and suspension waived and suspended one (1) practical nurse license for two years.
7. Placed one (1) practical nurse license on probation for two (2) years.
8. Referred two (2) imposters for impersonating a licensed practical nurse and practicing without a license in violation of the Nursing Practice Act.

THE NURSING PRACTICE ACT

The Nursing Practice Act which has been known as Senate Bill No. 108 has been reallocated its chapter in the statutes which is Chapter 335. Please note that the sections and subsections will not be numbered as they are designated in Senate Bill No. 108 but are 335.011 - 335.096 inclusive.

The new copies of the Nursing Practice Act will be available in the near future. Please note that the definition of our act is THE NURSING PRACTICE ACT. This is the legal definition of the act as defined in the beginning of the Nursing Practice Act, 335.011, RSMo., Supp. 1976.

## EMPLOYER'S RESPONSIBILITY

Employers of nursing personnel are reminded to verify that all registered professional nurses and licensed practical nurses are eligible to be employed by one of the following methods:

1. The nurse has a valid and current license to practice as a registered professional nurse or licensed practical nurse in Missouri.
2. The nurse has made application for license by endorsement in Missouri and has in her possession a temporary work permit from the Missouri State Board of Nursing.
3. New graduates from professional or practical out-of-state schools must have "Permission for out-of-state graduates to work pending results of first examination" permits from the Missouri State Board of Nursing.
4. Our own new graduates of Missouri State accredited schools may work pending the results of the first licensing examination scheduled by the Board.
