


DISCIPLINARY PROBLEMS CONSIDERED BY BOARD

At the October, 1977, and January, 1978 meetings, the Board considered:

1. Two (2) cases involving applicants who had arrest records prior to granting permission to write the State Board Test Pool Examination for professional nurse licensure; and four (4) practical nurse applications.
2. Four (4) complaints received by the Board against registered professional nurses and three (3) against licensed practical nurses.
3. Referred sixteen (16) cases to the Administrative Hearing Commission (hearings pending).
4. Denied five (5) applicants for registered professional nurse licensure and four (4) applicants for practical nurse licensure by reciprocity (did not meet Missouri's Minimum Education Requirements).
5. Conducted three (3) hearings to determine disciplinary action.
6. Suspended one (1) practical nurse license for two years.
7. Placed one (1) practical nurse license on probation for two (2) years.
8. Revoked one (1) practical nurse license.
9. Restored one (1) practical nurse license following termination of suspension.

CLINICAL FACILITIES OVERCROWDED

The Board is extremely concerned over the problem presented in many areas in Missouri relative to out-of-state schools sharing, and often times given preference, to the clinical facilities needed by our own Missouri students in nursing. The Board urges the Administrative staff to consider this problem seriously: in order to maintain accreditation by the Missouri State Board of Nursing clinical facilities must be available to the schools in order to insure graduates who are safe practitioners for our own Missouri residents.

The Board wishes to emphasize also that there must be agreement forms signed between schools using the same facilities for clinical laboratory experience. The following is a sample of an agreement.

POSITIONS ADOPTED BY THE MISSOURI STATE BOARD OF NURSINGRE: S.B. 835, STAGGERED LICENSE BILL

The Missouri State Board of Nursing opposes Senate Bill No. 835, Staggered Licensing Bill, because the Board's first priority is to safeguard the public, and the two-year license period would inhibit the process of repossessing the licenses that have been revoked or are under disciplinary status.

Among other concerns are the transferring of the final authority for the fee setting structure; and the lack of adequate documentation of a systematic and consistent distribution of pro-rata shares among the various boards.

RE: SENATE BILL NO. 866

The Missouri State Board of Nursing believes that neither the best interests of the consumers of health care nor the nursing profession can be served by passage of Senate Bill No. 866.

Passage would nullify the contract negotiated with the National League for Nursing for the administration and use of the State Board Test Pool Examinations which are national tests accepted by all states and territories for licensure of nurses. This contract contains specific guidelines and regulations for administration of this examination.

Further, passage of Senate Bill No. 866 would unnecessarily penalize the graduates of Missouri nursing schools by curtailing their interstate mobility, as well as nurses coming to Missouri, since interstate endorsements for licensure are dependent upon the use of the National State Board Test Pool Examinations.

RE: H.B. 1466, STAGGERED LICENSING BILL

The Missouri State Board of Nursing opposes House Bill No. 1466, (Staggered Licensing Bill) for the primary reason that a two-year license for a nurse would make it more difficult for the Board of Nursing to protect the consumer by allowing the nurse violator to continue practicing with a license for a longer period of time.

By statute, the Board of Nursing may refuse to renew a license and this Staggered Licensing Bill would inhibit the Board's ability to exercise proper control in safeguarding the public's health.

EMPLOYER'S RESPONSIBILITY

Employers of nursing personnel are urged to verify that they are registered professional nurses and licensed practical nurses are eligible to practice nursing in Missouri. Please ascertain that:

1. The nurse has a valid and current license to practice as a registered professional nurse or licensed practical nurse in Missouri. or
2. The nurse has made application for license by endorsement in Missouri and has in her possession a temporary work permit from the Missouri State Board of Nursing or
3. New graduates from professional or practical out-of-state schools must have "Permission for out-of-state graduates to work pending results of first examination" permits from the Missouri State Board of Nursing. or
4. Our own new graduates of Missouri State accredited schools may work pending the results of the first licensing examination scheduled by the Board.

CURRENT LICENSURE

All employers should check the current status of licensees and any irregularity that the license shows should be reported to the Board of Nursing immediately. The current license is dated July 1, 1977 to June 30, 1978; the colors are: R.N. - gray and L.P.N. - green.

EMPLOYMENT OF NEW GRADUATES

The Board's policy on employment of new graduates is that new graduates should work under supervision only until licensure has been completed.

EMPLOYERS ATTENTION PLEASE

The Board of Nursing is extremely concerned over the name of graduates from foreign nursing schools who have not passed the licensing examination and are functioning in the capacity of registered professional nurses even though they are classified as nurse-aides.

In order to fully understand the facts we are including the News release from the newly established Commission on Graduates of Foreign Nursing Schools. We anticipate that this Commission will render a great service to these graduates, employers, and the public receiving nursing care. Attached is a list of the Status of Inter-Country Applications from July 1, 1976 - June 30, 1977. From January 1, 1977 - December 31, 1977, we forwarded 647 applications to foreign countries. In order to see the increasing trend consider the fact that we have honored 241 requests in the last six weeks.

FIRST EXAMINATION TO BE GIVEN WEDNESDAY, OCTOBER 4, 1978
FOR FOREIGN NURSE GRADUATES WISHING TO IMMIGRATE,
PRACTICE NURSING IN THE U.S.A.

PHILADELPHIA, Pa. -- The first screening examination for professional nurses throughout the world who wish to immigrate to the United States and practice nursing will be given at 32 locations in 30 countries on Wednesday, October 4, 1978, it was announced here today by the Commission on Graduates of Foreign Nursing Schools (CGFNS).

The independent, non-profit Commission was established recently at the suggestion of the Division of Nursing, Bureau of Health Manpower, U.S. Department of Health, Education and Welfare, under the sponsorship of the American Nurses' Association and the National League for Nursing, to assure the profession's responsibility concerning foreign nurses wishing to immigrate to the United States. The Commission's screening examination will cover proficiency in both nursing practice and in English comprehension. Both phases of the test will be given in the English language.

The nursing examination will cover the same five areas of nursing (medical, surgical, obstetric, pediatric and psychiatric) which nurses are taught in the United States and are covered by state licensing examinations, it was explained by Adele Herwitz, executive director of the Commission.

Passing the one-day CGFNS Qualifying Examination "will assure a reasonable possibility of passing the nursing examination given by the 50 states, the District of Columbia, Guam and the Virgin Islands as a prerequisite for licensing and professional practice as a registered nurse (R.N.)," Miss Herwitz said.

Test Will Help Determine Eligibility For Immigration

Obtaining a CGNS Certificate, signifying a passing grade, also is expected to: (1) help determine eligibility of foreign nurse graduates for immigration under a preference visa by the U.S. Immigration and Naturalization Service, (2) be required as a criterion for taking state licensing examinations, and (3) be helpful in obtaining a work permit for foreign nurse graduates from a U.S. Labor Department regional office.

The U.S. Immigration and Naturalization Service has advised the Commission that "it would be prepared" to require nurses to pass the new examination, Miss Herwitz said.

She added that the state nursing boards are expected to require graduates of foreign nursing schools to pass the Commission's examination in their own countries to be eligible to take the State Board Test Pool Examination in the United States.

The Commission was established by this country's two major nursing organizations, the American Nurses' Association and the National League for Nursing, to test foreign nursing school graduates in their own countries. This will prevent exploitation of those who fail state licensing exams, and help assure the American public of safe patient care, Miss Herwitz said. Until recently, Miss Herwitz was executive director of the International Council of Nurses, the world organization of nurses.

High Failure Rate on Licensing Exams

Miss Herwitz said that in recent years, a high percentage of foreign nurses have not passed the state licensing examinations. Aside from their great disappointment, she said, these unlicensed nurses have been exploited by being placed in lowpaid positions in hospitals and other health care centers.

When foreign nurses who fail the state nursing examinations have had to leave the country, they have felt discriminated against and disenchanted with the United States, the nursing official pointed out.

Or, others have remained in this country and "have been hired as nurses aides and then pushed into taking registered nurse responsibilities on unpopular night shifts

and/or in out-of-the-way communities," she continued. "This has not contributed to safe patient care," she added.

Between 1972 and 1976, more than 42,000 foreign nurse graduates came to the United States on a temporary or permanent basis. Of 15,077 foreign nurse graduates who took state licensing examinations in 1975, fewer than 20 per cent passed.

"Of the foreign nurse graduates taking state examinations in 1976," Miss Herwitz said, "84 per cent failed. These people had presumably received their visas to immigrate on the basis of being able to practice as nurses, and then, not being licensed, were not able to hold positions as registered nurses. Part of this problem probably can be attributed to the lack of fluency in the English language."

"Our Commission supports the U.N. Declaration of Human Rights, which affirms the freedom of the individual to migrate," the CGFNS executive director said. "However, we do not seek to encourage or discourage immigration. Rather, our goal is to help foreign nursing school graduates determine their probable qualification as full-fledged professionals before they leave their own countries, and to help assure the American public of safe patient care."

Applications Will Be Available in February, 1978

To take the test on Wednesday, October 4, applicants must have graduated from a secondary school and a government-approved nursing school whose 2-year or more curriculum covers medical, surgical, pediatric, psychiatric and obstetric nursing, and have passed any licensing examination required by the applicant's own country. A completed application, a \$65 U.S. examination fee, and certain documents must be submitted to the Commission. Completed applications will be received starting March 1; the deadline is July 1.

Starting in February, applications and a detailed Information Booklet may be obtained from American embassies, consulates or missions, from national nursing associations, and from the Commission at 3024 Market St., Philadelphia, Pennsylvania 19104.
