If you drive from the eastern part of the state via I-70, exit at the Kingdon City, Highway 54 West, State Capitol Exit. Proceed to Jefferson City via Highway 54 West, cross the bridge and take the Highway 50 West (Sedalia) Exit. Proceed on Highway 50 West to the second stop light, turn right onto North Ten Mile Drive. Our office is located in a metal, cream-colored building, .8 of a mile north of the Capital Mall.

If you drive from the western part of the state via I-70, exit at the Highway 63 South, Jefferson City Exit in Columbia and proceed into Jefferson City via Highway 63 South. After crossing bridge, proceed as above.

If you drive from the western part of the state via Highway 50 East, turn left onto North Ten Mile Drive at the first stop light after passing the city limits sign, and follow this street until you reach our building as described above.

The February, 1983 professional nurse examination will be held even if weather is bad.

PLEASE NOTE THE EXPIRATION DATE ON THE 1982-83 LICENSES. R.N.'s will expire on April 30, 1983. The R.N. renewals should be mailed from Professional Registration in late February, 1983. L.P.N.'s will expire on May 31, 1983. The L.P.N. renewals should be mailed in late March, 1983.

IF YOU HAVE AN ADDRESS AND/OR NAME CHANGE, PLEASE NOTIFY THIS OFFICE AS SOON AS POSSIBLE TO INSURE RECEIVING YOUR RENEWAL NOTICE.

If you do not receive your renewal notice at least one month before you are scheduled to renew, CONTACT THIS OFFICE.

The renewal notices will be of different type this year, i.e., an 8½ x 11 sheet of computer paper, instead of the card as you have received in the past. The Board is being completely converted to computer and so the turn-around time should be much shorter and the system will become more efficient.

IMPORTANT: R.N. licenses not renewed by April 30, 1983, will have a 30-day period in which to renew without penalty, i.e. May 30, 1983. Any renewals postmarked after that date will be assessed a \$25.00 lapsed fee.

L.P.N. licenses not renewed by May 31, 1983 will have a 30-day period in which to renew without penalty, i.e. June 30, 1983. Any renewals postmarked after that date will be assessed a \$25.00 lapsed fee.

INTERMEDIARIES: Discussion was held concerning the intermediary issue. Input was obtained from representatives from the Missouri Association of Hospital Pharmacists and the Missouri Hospital Association. FROM THE EXECUTIVE

The October NCLEX-PN Examination was administered using the direct application system with the new testing service CTB/McGraw Hill of California. The staff of the Board of Nursing was quite pleased with the changes which have occurred. The advantages to having the candidates mark their answer in the test booklets and computer print-outs of candidates have helped efficiency and flow of work concerning administration of the examination.

The Board was quite pleased with the results from the July NCLEX-RN Examination. With the new criterion reference scoring the Missouri failure rate dropped from approximately 10% to 5%. We hope that this trend continues.

I am reprinting for you questions and answers on the licensure examination from the Issues, a publication from the National Council of State Boards of Nursing, Inc., Volume 3, Number 1, Spring 1982.

- Q. What is the name of the licensure examination developed by the National Council of State Boards of Nursing?
- A. The examination was known as the State Board Test Pool Examination (SBTPE) for many years. Beginning with the April, 1982 practical nurse examination and the July, 1982 registered nurse examination the name of the examination will be the National Council Licensure Examination (NCLEX). When referring to a specific type of examination, NCLEX-RN or NCLEX-PN will be used.
- Q. When does the new registered nurse test plan become effective?
- A. The new registered nurse test plan will be implemented with the examination to be administered in July, 1982. The test plan is based on the behaviors of the nursing process, the decision making process concerning health requirements and cognitive ability. Because it is a comprehensive examination, there will only be one score.
- Q. What is the recommended passing score for each examination?
- A. The recommended passing score for the NCLEX-RN is 1600 and is effective with the July, 1982 administration. The recommended passing score for NCLEX-PN is 350. Because each Board of Nursing establishes its own passing score, candidates are encouraged to secure specific information from the jurisdiction in which they are seeking licensure.
- Q. Is there a correction for guessing used in scoring the examination?
- A. There is no correction for guessing in scoring either the NCLEX-RN or the NCLEX-PN. In February, 1982 the registered nurse examination was scored with and without the correction for guessing and the higher score was assigned. This double scoring was done because some candidates stated that they were confused about the change in scoring.
- Q. When will the scoring on NCLEX be changed from norm-referenced to criterion-referenced?
- A. Criterion-referenced scoring will become effective with the July, 1982 NCLEX-RN and October, 1982 NCLEX-PN administrations.

- Q. What is the difference between a norm-referenced and a criterion-referenced examination?
- A. In norm-referenced scoring each score is interpreted in terms of its relative standing in the group of scores obtained by the candidates taking that examination. In criterion-referenced scoring, each score is judged in terms of an acceptable level of competence established by a panel of judges who are knowledgeable about entry-level performance.
- Q. What is the reading level of the examination?
- A. NCLEX-RN has a general tenth grade reading level and NCLEX-PN has a general eighth grade reading level. Technical language must match the language of the text books used by programs preparing for registered nurse licensure or by programs preparing for practical nurse licensure.
- Q. How long are the examinations?
- A. NCLEX-RN is a two day examination which consists of four books with approximately 120 questions in each book; each book is administered in a two hour time segment. NCLEX-PN is a one day examination which consists of two parts with approximately 120 questions in each part; each part is administered in a two hour time segment.
- Q. Because there will only be one score for future examination, how will failing candidates know what to study?
- A. A task force is developing a diagnostic profile for consideration by the Examination Committee and Delegate Assembly. The profile which will be available to all failure candidates will follow the test plan and will be limited to 50 subcategories or listing for NCLEX-RN and 25 for NCLEX-PN.

A DIAGNOSTIC ASSESSMENT PROGRAM FOR THE NCLEX-RN: Now available. The program is sponsored by the National Council of State Boards of Nursing. The program is designed "to provide candidates for licensure with specific information about their performance in the knowledge and skill areas tested by NCLEX", according to ASI. The cost of the program is \$25.00 per candidate. An information brochure and order form may be obtained by contacting the Board office.

REVISION OF RULES AND REGULATIONS:

At the October, Board meeting the Board reviewed the Rules and Regulations which applied to fees collected by the Board. It was the Board's decision to revise the rules so that required fees could be in any form (money order, personal check, or cash). These revisions will be published in the November Missouri Register and public comments will be accepted.

AVAILABILITY OF VIDEO-TAPE REGARDING NCLEX

To assist those who are helping nursing students prepare for the National Council Licensure Examination for Registered Nurses, the National Council is presently in the process of producing a 30-40 minute color video presentation that will answer questions and help calm the fears of students preparing to take the licensure examination.

In time to help those students who are planning to take NCLEX-RN in February, 1983, the video tape will be available for purchase mid-December, 1982, from Chicago Review Press, 213 West Institute Place, Chicago, Illinois 60610.

The video tape will feature Dr. Eileen McQuaid Dvorak answering the questions of senior nursing students preparing to take NCLEX-RN themselves. Their questions will reflect the typical concerns and problems that nursing students have been asking Dr. Dvorak to address in her numerous presentations on NCLEX throughout the country.

Detailed visual instructions on how to fill out the application form for NCLEX-RN will also be included as part of the video presentation.

DEADLINE FOR MAILING REQUESTS FOR HAND SCORING:

The National Council of State Boards of Nursing Board of Directors has determined that requests for hand scoring must be postmarked no later than thirty (30) days after the Board mails score reports to candidates. The following is the procedure for hand scoring:

1. Candidates request information from Board of Nursing about hand scoring.
2. Board distributes request form and instructional cover letter to candidate.
3. Candidate submits request form and fee to NCSBN.
4. NCSBN forwards request to test service.
5. Test service hand scores test booklets and returns results to NCSBN.
6. NCSBN returns results of hand scoring to the Board and to the candidate.

Cost: The charge for hand scoring NCLEX-PN is \$100.00.
The charge for hand scoring NCLEX-RN is \$115.00.

NEWS ITEM: The Missouri State Board of Nursing has been permitted to intervene as a defendant in the case which the Missouri Hospital Association filed against the Department of Social Services regarding the question of whether under the Nursing Practice Act Licensed Practical Nurses may administer Intravenous Fluids. The trial is currently set for December 16, 1982, at 3:00 p.m. in Division 1, of the Circuit Court of Cole County. If you plan on attending you need to check with the Board office to verify the date prior to traveling to Jefferson City.

NEW BOARD MEMBER APPOINTED BY GOVENOR BOND

Elora (Sissy) R. Borgmeyer, has been appointed by Govenor Bond and confirmed by the Senate as a Public Member to the State Board of Nursing. Mrs. Borgmeyer is the first Public Member on the Missouri State Board of Nursing pursuant to Chapter 335.021, RSMo. 1981. According to the law Mrs. Borgmeyer is a nonvoting Public Member and "Shall be at the time of his appointment a citizen of the United States; a resident of this state for a period of one (1) year and a registered voter; a person who is not and never was a member of any profession licensed or regulated under this chapter or the spouse of such person; and a person who does not have and never has had a material, financial interest in either the providing of the professional services regulated by this chapter, or an activity or organization directly related to any profession licensed or regulated under this chapter". Mrs. Borgmeyer has worked as a cashier, a bookkeeper, a sales clerk, and a manager of AseI Travel Service in Jefferson City, Missouri.

The Board welcomes Mrs. Borgmeyer and is looking forward to a long productive relationship with our new Public Member.

The Board reviewed a reorganization plan of the Division of Mental Retardation, Developmental Disabilities because of questions from L.P.N.'s within that Division. Under the new reorganization graduate nurses who spend 70% or more time in providing residential services and evening and night nurses will be directly assigned to the Coordinator of residential living (a graduate nurse) and remain in nursing classifications. Thus, L.P.N.'s should be directly responsible to a Registered Nurse. The Board feels this reorganization plan is within the guidelines of the Nursing Practice Act, Chapter 335.

DISCIPLINARY ACTIONS

1. Roger Paul Bahr, R.N. #73523, St. Louis, Missouri - REVOKED. In 1980, Mr. Bahr falsified certain narcotic logs and records of a hospital and misappropriated Demerol. The Board REVOKED Mr. Bahr's license following the January, 1982 Board meeting but stayed the imposition of the Order of Revocation placing Mr. Bahr's license on suspension. Mr. Bahr met with the Board July, 1982, and the Board issued an order continuing the stay of the Order of Revocation and continued the suspension until the October, 1982, Board meeting. On or about August 6, 1982, Mr. Bahr sought employment at a hospital displaying a current nursing license. The Order of Revocation was issued.
2. Jackie Gauda, R.N. #18898, St. Louis, Missouri - REVOKED. Mrs. Gauda was found unfit or incompetent by reason of neglect, lack of professional skill or otherwise in that the storing of medications and her failure to keep records upon the basis of a belief that no such record keeping responsibilities existed demonstrates a fundamental unfamiliarity with minimal standards of medication storage and of record keeping in the profession. Mrs. Gauda was found guilty of unprofessional conduct or any act derogatory to the morals or standing of those engaged in the care of the sick by storing medications in such fashion that they were scattered about her office sitting out in the open, no lids on bottles, and spilled out of the bottles. Mrs. Gauda owned and operated the Gauda Foster Home for Adults, in St. Louis, Missouri throughout the 1970's.
3. Donna Marie Davis Harris, L.P.N. #19533, St. Louis, Missouri - REVOKED. Mrs. Harris in 1981 falsified hospital records by indicating on patients' charts that she had administered Demerol when in fact she had not. Mrs. Harris administered the Demerol which she misappropriated to herself.
4. Linda Louise Zink Hesterlee, L.P.N. #17369, Leavenworth, Kansas - REVOKED. In November, 1981, Mrs. Hesterlee's license to practice practical nursing was revoked by the Arizona State Board of Nursing, because she took controlled substances from hospital supplies for her own use.
5. Mary Martha Burrell Little, R.N. #80134, Jefferson City, Missouri - SUSPENDED with stay of imposition and license placed on PROBATION for 1 year. In November, 1981, Mrs. Little was convicted in the Associate Circuit Court of Cape Girardeau County, Missouri, for misdemeanor possession of Marijuana.
6. Julie Ann Curran McCormack, R.N. #75275, Rolla, Missouri - REVOKED. Mrs. McCormack misappropriated Darvocet, Tylenol #3, and Demerol from a Nursing Home for her own use. Mrs. McCormack has been diagnosed as being addicted to Ethyl Alcohol, Opiates, and Opiate type drugs.
7. Gail Phyllis Gaines McFeders, R.N. #53945, Kansas City, Missouri - REVOKED. In October, 1981, Mrs. McFeders misappropriated Demerol, injected it into herself while on duty and falsified hospital records.
8. James Dee Noble, R.N. #83682, Kansas City, Missouri - REVOKED. In November, 1981, Mr. Noble removed Demerol from tubexes and replaced it with another liquid substance.
9. Laurie Colleen Parker, R.N. #66692, Kansas City, Missouri - REVOKED. Imposition of the Order of Revocation stayed and licensee placed on PROBATION for 4 years. In March, 1981, Miss Parker misappropriated from the narcotic supplies of a hospital Demerol and administered them to herself prior to going off duty.

10. Wilda Blaylock Price, R.N. #43035, Cape Girardeau, Missouri - REVOKED. In November, 1981, Mrs. Price misappropriated Morphine from the emergency room of a hospital, falsified medical records and admitted that she has a drug problem for which she admitted to treatment.
11. Sharon Emily Cooper Roellig, R.N. #39288, St. Charles, Missouri - REVOKED. In 1981, Mrs. Roellig misappropriated Demerol from the narcotic supplied of a hospital and administered it to herself via injection on a repetitive and frequent basis.
12. Irene Haywood Roland Smith aka Irene Scott, R.N. #62197, St. Louis, Missouri - REVOKED. Imposition of the Order of Revocation stayed and the licensee placed on PROBATION for a period of 2 years. In 1979, Ms. Smith appeared in the United States District Court for the Eastern District of Missouri and pleaded guilty to and was convicted of knowingly and intentionally possessing with specific intent to distribute approximately 12.36 grams net weight of cocaine.
13. Denese Louise Struckhoff Palmer, R.N. #72464, Columbia, Missouri - REVOKED. In November, 1979, Mrs. Palmer was found asleep in the surgical intensive care unit while on duty at a St. Louis hospital. Mrs. Palmer has completed a drug and alcohol rehabilitation program.
14. Patricia Loraine Hawkins Umfleet, L.P.N. #29677, Tipton, Missouri - CENSURE. In October, 1981, Mrs. Umfleet was convicted in the Circuit Court of Cole County on two counts of forgery.
15. Janet June Witherspoon Zimmerman, R.N. #31618, Ballwin, Missouri - REVOKED. As the result of a hearing held on April 29, 1982, the license of Mrs. Zimmerman was revoked, imposition of revocation stayed and license suspended for 6 months from 4/30/82 to 10/30/82. Following suspension licensee was placed on probation for two years. Licensee was to provide proof that she had initiated treatment in A Sleep Disorder Program. When the licensee appeared before the Board on October 5, 1982, she failed to provide proof that she had initiated treatment in the sleep disorder program and further admitted that she had not initiated such treatment. In 1977, Mrs. Zimmerman backdated prescriptions given to her by a physician and from 1977 through October, 1980 Mrs. Zimmerman obtained biphentamine by using a false name.
16. Deborah Susan Goodwin Patterson, L.P.N. #25538, Caruthersville, Missouri - PROBATION ENDED, October 6, 1982.
17. Donald Lee Rehkop, R.N. #58326, Desloge, Missouri - PROBATION ENDED October 6, 1982.
18. Joyce Ann Fuemmeler Robinson, L.P.N. #15690, Columbia, Missouri - PROBATION ENDED October 7, 1982.
