JULY, 1984 NCLEX-RN EXAMINATION SITES

The July, 1984 NCLEX-RN examination will be given in St. Louis at Cervantes Convention Center, 801 Convention Plaza, St. Louis, Missouri and at the University Plaza Hotel, 333 Sherman Parkway, Springfield, Missouri in the Convention Center.

Regular Board meetings are held at the Division of Professional Registration, 3523 North Ten Mile Drive, Jefferson City, Missouri, beginning at 8:30 a.m. each day unless otherwise designated. Meetings are open to the public except for discussion of licensure disciplinary problems. A Public Agenda is published for each meeting.

If you drive from the eastern part of the state via I-70, exit at the Kingdom City, Highway 54 West, State Capitol Exit; proceed to Jefferson City via Highway 54 West. Cross the bridge and take the Highway 50 West (Sedalia) Exit. Proceed on Highway 50 West to the second stop light, turn right onto North Ten Mile Drive. The office is located in a metal, cream-colored building, approximately .8 of a mile north of the Capital Mall.

If you drive from the western part of the state via I-70, exit at the Highway 63 South, Jefferson City Exit in Columbia and proceed into Jefferson City via Highway 63 South. After crossing the bridge, proceed as above.

If you drive from the western part of the state via Highway 50 East, turn left onto North Ten Mile Drive at the first stoplight after passing the city limits sign, and follow this street until you reach our building as described above.

If you drive from the eastern part of the state via Highway 50 West, go all the way through Jefferson City until you reach the Capital Mall, turn right onto North Ten Mile Drive and proceed .8 of a mile north to our building as described above.

If you drive from the southern part of the state via Highway 54. Take the Highway 50 West (Sedalia) Exit. Proceed on Highway 50 West as described above.

INACTIVE, LAPSED, LICENSED IN ANOTHER STATE:

Missouri has mandatory licensure.

It is illegal to practice nursing in Missouri without a current Missouri license. A large number of persons who are posing as nurses are applying for employment in Missouri or are working in Missouri with lapsed licenses or inactive licenses. The Board office is asking for the assistance of those in administrative positions in facilities which employ nurses. This can be done by:

1. Hiring only people who can display a current license or temporary permit at the initial interview.
2. Developing a procedure for assuring currency of licensure and timely renewal for all licensed personnel.
3. Spreading by the word of mouth to reach those outside the arena of major employers of nurses.
4. When applicable, verifying that new graduates have passed the licensure examination and a license will be issued.

ALL NURSES MUST BE LICENSED IN MISSOURI, HAVE CURRENT TEMPORARY PERMIT, OR FALL WITHIN THE EXEMPTION CLAUSE IN THE NURSING PRACTICE ACT WHICH STATES THAT NEW GRADUATES MAY PRACTICE UNDER PROPER SUPERVISION PENDING THE RESULTS OF THE FIRST LICENSING EXAMINATION SCHEDULED BY THE BOARD FOLLOWING GRADUATION.

DISCIPLINARY HEARINGS HELD AT THE APRIL 2-6, 1984 BOARD MEETING

1. Mary Alice Jones, R.N. #74794, Current 83-84, L.P.N. #15324, Inactive, Kennett, Missouri. REVOKE, REVOCATION STAYED, PROBATION FOR TWO YEARS WITH CERTAIN TERMS AND CONDITIONS. On application to take the RN licensure exam in Missouri, Ms. Jones answered no to the question "Have you ever been convicted, as an adult offender of any crime (excluding traffic violations except drunken driving)?" She had been convicted of a felony regarding theft and use of a credit card.
2. Donna Haslam Cochran, L.P.N. #25250, Current 83-84, Kansas City, Missouri. REVOKE, REVOCATION STAYED, PROBATION FOR THREE YEARS WITH CERTAIN TERMS AND CONDITIONS. On or about December 2, 1982 on several different occasions licensee filled out narcotic charge slips for Demerol, patients never received the Demerol which had been charged to them.
3. Catherine Burke Boeger, R.N. #87535, Current 83-84, Fort Dodge, Iowa. REVOKE. Licensee misappropriated Demerol from hospital supplies on a frequent and repetitive basis, and administered the drugs to herself.
4. *Stayed* Marc Steven Dufrenne, R.N. #62702, Current 83-84, O'Fallon, Missouri. REVOKE. Licensee was convicted in the State of Missouri, misappropriated Morphine and supplied it to another person for sale.
5. Scott Alan Fitch, R.N. #79023, Decatur, Illinois. REVOKE. Licensee had license suspended until April, 1984 meeting with the Board. Licensee's Illinois license was placed on probation in March, 1982, for two (2) years because of drug addiction.
6. Karen Elizabeth Bockstahler, R.N. #86690, Lapsed 83-84, Cincinnati, Ohio. REVOKE. Licensee altered an order for a non-narcotic analgesic to include an order for Demerol. Licensee also signed out larger amounts of narcotic than were ordered and did not use proper hospital procedure to indicate wastage.
7. Georgann Barrett Smallwood, R.N. #78812, Current 83-84, Joplin, Missouri. REVOKE. During working hours, licensee was observed to have slurred speech, unsteady gait, rambling speech and unkempt appearance; did not follow proper procedure for wasting medications; increased frequency with which pain medications were administered, but instructed LPN's to chart medication as though they had been administered with normal frequency. Licensee made errors in dispensing drugs from the pharmacy, and at one time became unconscious on duty and was incapable of administering intravenous medications.
8. Constance Marie Anson, R.N. #84819, Current 83-84, Kansas City, Kansas. REVOKE, REVOCATION STAYED, PROBATION FOR THREE YEARS WITH CERTAIN TERMS AND CONDITIONS. Licensee mischarted various controlled substances, administered a medication to a patient which had not been ordered, administered controlled substance to herself while on duty, allowed a patient to remain in a room for extended periods. Kansas Board of Nursing revoked the licensee's license to practice registered professional nursing on January 21, 1983.

9. Jana Snyder, R.N. #71494, Current 83-84, New York, New York. Hearing for violation of probation. Licensee returned to previous probationary status without penalty.
10. Betty Ellen Owens, L.P.N. #19852, Current 83-84, Monett, Missouri. SUSPENDED FOR SIX MONTHS. Licensee violated terms of probation by appearing intoxicated on duty on two (2) occasions, accepting a gift from a patient, and removing materials from the supplies of the nursing home in which she was employed without permission for her own personal use.
11. Glenda Carol Terry Trankler, R.N., #89685, Current 83-84, Arnold, Missouri. SUSPENSION FOR SIX MONTHS THEN THREE YEARS PROBATION. Licensee diverted Demerol on numerous occasions from medications supplied for patient usage for personal use, and substituted Vistaril in the Demerol vials.
12. *Stayed* Suzanne Ivanuck Carter, R.N. #57502, Current 83-84, Natchez, Mississippi. REVOKE. On February, 18, 1983, the Mississippi Board of Nursing revoked licensee's Mississippi endorsement Temporary Permit for falsifying, or in a repeatedly negligent manner, making incorrect entries or failing to make essential entry on records, and for misappropriating medication.
13. James W. Fetters, R.N. #55554, Lapsed 83-84, Overland Park, Kansas. REVOKE. On April 28, 1983 Kansas State Board of Nursing revoked the Kansas license for failing to chart entries from hospital narcotic records onto patient medication record and signing out narcotics for patients more frequently than ordered by the physician. The drugs involved were Demerol and Vallium.

LPN/IV RULE CLARIFICATION AND INTERPRETATION

Section 4 E of the IV Rule is not limited to IV push medication but covers all acts of intravenous fluid therapy administration by LPN's who have passed a course approved by the State Board of Nursing.

Any IV Course approved prior to April 12, 1984 may commence under the IV Emergency Rule in effect at that time. Any such approved program which starts its first class after April 12, 1984, when the new rule became effective, will submit changes in writing to the Acting Executive Director of the Missouri State Board of Nursing for approval.

CSR 200-6.010 INTRAVENOUS FLUID TREATMENT ADMINISTRATION

(1) Definitions:

(A) Administration of Intravenous fluid treatment is the therapeutic infusion and/or injection of substances through the venous system.

(B) Administration is the comprehensive activity which includes, but is not limited to: Observing, initiating, monitoring, discontinuing, maintaining, regulating, adjusting, documenting; and assessing, diagnosing, planning, intervening and evaluation.

(C) Intravenous Fluid Treatment Administration is a responsibility of the Registered Professional Nurse, as ordered by an individual licensed in the state of Missouri to prescribe medications and treatments.

The Registered Professional Nurse may delegate selected activities associated with the administration of intravenous therapy. The Registered Nurse may delegate certain of these activities to experienced, qualified, appropriately educated Licensed Practical Nurses in keeping with the Registered Nurse's professional judgment and standards that are established within the agency providing the intravenous therapy service.

(D) "Under the direction of a Registered Professional Nurse" means that Registered Professional Nurses may delegate intravenous therapy functions to Licensed Practical Nurses who have passed an approved course. The Registered Professional Nurse does not necessarily have to be on the premises in order for the Licensed Practical Nurse to perform the delegated functions.

(2) Upon completion of a generic practical nursing program approved by the State Board of Nursing, an LPN may observe and monitor intravenous fluid treatment, maintain the calculated flow rate of intravenous infusions, report and document observations and procedures performed.

(3) In addition to functions identified in (2), Licensed Practical Nurses who have satisfactorily completed an approved course of instruction may perform the following functions and duties relating to the administration of intravenous fluid treatment under the direction of a Registered Professional Nurse.

- (A) Calculating the rate of intravenous fluid infusions.
- (B) Discontinuing of intravenous fluid treatment.
- (C) Adding parenteral solutions to existing patent intravenous lines.
- (D) Changing intravenous tubings and dressings.

(E) Initiating intravenous fluid treatment following assessment of patient status by a Registered Nurse with documentation on the patient record.

(F) Initiating intravenous fluid treatment only peripherally and only with devices which do not exceed three (3) inches in length.

(G) Adding, to existing patent intravenous lines, designated premixed medications, via intravenous piggy-back, either by continuous or intermittent methods.

(H) Maintaining the patency of Heparin Locks.

(4) Licensed Practical Nurses MAY NOT perform the following functions or duties related to the administration of intravenous fluid treatments:

(A) Initiating TPN fluids.

(B) Initiating or adding anti-neoplastic agents.

(C) Initiating or adding blood/blood components.

(D) Performing hemodynamic monitoring or tasks related to it.

(E) Administering drugs IV Push. (Life-threatening circumstances may necessitate the administration of IV push medications by experienced/qualified Licensed Practical Nurses under the direction of a Registered Nurse or physician.)

(F) Initiating or adding the following categories of drugs:

1. Antihypertensives
2. Vasopressors
3. Aminoglycosides
4. Antiarrhythmics
5. Oxytocics
6. Anticonvulsants
7. Narcotics
8. Anticoagulants
9. Anesthetic agents
10. Experimental drugs
11. Barbiturates
12. Immunosuppressive drugs

13. Enzymes

(G) Initiating or adding the following specific drugs:

1. Mannitol
2. Insulin
3. Aminophylline

(5) Application Procedures for I.V. Fluid Treatment Program

(A) Purpose of Approval: To establish basic preparation for Licensed Practical Nurses to perform the administration of Intravenous fluid treatments within the scope authorized by the rules and regulations.

(B) Types of Programs approved.

1. Postgraduate programs offered by colleges and vocational-technical schools.
2. Programs offered by health care facilities which provide Intravenous therapy.

(C) Procedure for Initial Approval.

1. An Institution desiring to obtain approval for an Intravenous Fluid Treatment Program shall submit a proposal to the State Board of Nursing. The proposal shall be written by and bear the signature of a Registered Professional Nurse who is currently licensed to practice as a Registered Professional Nurse in Missouri.

2. An Institution submitting a proposal for Initial approval shall include in the proposal any information it deems pertinent, however the proposal shall contain the following:

- A. Objectives of the program. Terminal objectives shall identify behaviors expected of the graduates at the completion of the program.
- B. Qualifications of the faculty of the program.
- C. Curriculum.
- D. Maximum faculty-student ratio in the clinical component.
- E. Number of hours of classroom instruction and number of hours of clinical practice under the supervision of a Registered Professional Nurse designated by the sponsoring agency.
- F. Description of the training facilities which will be used by the program. The description shall be sufficiently detailed to establish that the training facilities will meet the standards required of training facilities under these rules and regulations.

G. Mechanism through which the Institution will determine that LPN's seeking admission to the program meet the admission requirements established by these rules and regulations.

H. Methods of student evaluation which will be used.

(D) An Institution which has previously obtained approval shall comply with any subsequent changes in this rule beginning with the first class which begins the course following the effective date of the rule change. The Institution shall submit a report to the State Board of Nursing indicating the manner in which it will comply with the change in the rule. After the State Board of Nursing reviews the report, if the board approves the manner in which the institution will comply, the board shall notify the institution of its approval. If, after review, the board determines that the manner in which the institution will comply is not adequate, the board shall notify the institution of the inadequacies. Following such notification, re-approval of the program will be required before the institution begins its next class.

(E) Program Changes Requiring Board Approval or Notification.

1. All changes in information required to be provided in the initial proposal require board approval. Requests for approval of such changes shall be submitted to the board in writing three (3) weeks prior to the next regularly scheduled board meeting and shall be approved by the board before implementation. Changes in the faculty of the program do not require board approval. The program shall notify the board in writing of faculty changes.

(6) Standards for Curriculum

(A) The purpose of the Intravenous Fluid Treatment Program shall be to prepare Licensed Practical Nurses to perform limited intravenous fluid treatment. The program shall be designed to teach knowledge, skills, and competencies in administration of intravenous therapy which will qualify Licensed Practical Nurses to perform this procedure safely.

(B) The course shall consist of at least forty (40) classroom hours of instruction and a minimum of eight (8) hours of clinical practice under the supervision of a Registered Professional Nurse designated by the sponsoring agency, including a final written and practical examination.

(C) Course Prerequisites--The Licensed Practical Nurse shall meet the following pre-requisites prior to enrolling in the course:

1. Current licensure as a Licensed Practical Nurse in the State of Missouri.

2. Have taken a pre-test in pharmacology, anatomy, physiology and asepsis to be used as a diagnostic tool to determine level of knowledge.

(D) Faculty Qualifications.

1. Each faculty member shall be currently licensed to practice as a Registered Professional Nurse in the state of Missouri.

2. Each faculty member shall have a minimum of three (3) years clinical experience immediately prior to his or her appointment.

3. Non-nurse lecturers shall have professional preparation and qualifications for the specific subject area in which they are involved.

(E) Training Facility.

1. All classrooms shall contain sufficient space, equipment and teaching aids to meet the course objectives.

2. The facility in which clinical practice and the final practicum will be conducted shall allow students and instructors access to the intravenous therapy equipment and access to intravenous therapy recipients and to the pertinent records for purpose of documentation.

3. There shall be a signed written agreement between the sponsoring agency and a cooperating health care facility which specifies the roles, responsibilities and liabilities of each party. This written agreement will not be required if the only health care facility to be used is also the sponsoring agency.

(F) Testing

1. The student shall achieve a passing grade on a final exam which shall consist of written and clinical components.

2. The clinical exam shall include evaluation of the achievement of the clinical objectives of the course.

3. The instructor shall complete the final records and the record sheet shall include competencies and scores.

(G) Records

1. The agency conducting the intravenous course shall maintain the records of the individuals and shall submit to the Missouri State Board of Nursing the names, addresses and license numbers of all individuals who have successfully completed the program.

2. A copy of the final record shall be provided to the Licensed Practical Nurse.

3. The agency conducting the Intravenous therapy course shall award a certificate documenting successful completion of the approved program by the Missouri State Board of Nursing to the Licensed Practical Nurse, upon successful completion of the course.

(7) Intravenous Fluid Treatment Administration Course Guidelines--An Intravenous Fluid Treatment Administration Course shall have the following components:

(A) Review of the Missouri Nursing Practice Act and the policies and procedures of the clinical agency where practical experience is received.

(B) Structure of the circulatory system including site and function of the veins used for venipuncture.

(C) Relationship between intravenous fluid treatment administration and the body's homeostatic and regulatory functions, with attention to the clinical manifestations of fluid and electrolyte imbalance and cellular physiology.

(D) Principles of infection control in intravenous fluid treatment administration.

(E) Identification of various types of equipment used in intravenous fluid treatment administration with content related to criteria for use of each and means of trouble-shooting for malfunctions.

(F) Principles of compatibility and incompatibility of drugs and solutions.

(G) Nursing management of special intravenous fluid treatment administration procedures that are commonly used in the clinical setting, such as heparin lock.

(H) Procedure for venipuncture, including psychological preparation, site selection, skin preparation, puncture, anchor, collection of equipment and documentation.

(I) Maintenance of intravenous fluid treatment administration system: discontinuing intravenous fluid treatment administration, monitoring infusion, changing containers and tubing, care of site, etc.

(J) Nursing management of the patient receiving drug therapy, including actions, interactions, adverse reactions, methods of administration and assessment.

(K) Signs and symptoms of local and systemic complications in the delivery of fluids and medications and the preventive and treatment measures for those complications.

(L) Calculation of fluid and drug administration rates.
