PHILOSOPHY FROM FLO

I want to express my appreciation for the several invitations to visit received from nursing service. There are several yet that I have been unable to work into my schedule but I assure you I will and am looking forward to visiting everyone. Those I have visited have been most gracious and we had a pleasant, informative time. I want to learn about the issues which are troublesome to you in your setting and in turn share information which I have picked up in my conversation with others. I also have facts regarding misuse, abuse, and misappropriation of drugs which I can share and thus maybe help prevent some problems. I would appreciate hearing from many more of you. Can't offer you a reward of lottery tickets nor can I give you a discount on your license renewal as an incentive, but I can promise you a joke and you'll also get to see first hand the effects of advancing Alzheimer's Disease on one perfectly good nurse.

In past newsletters I have commented to a small degree on power and the nursing profession. I feel a compelling need to extend those comments. The compulsion comes in part from the frustration of negotiating the great vast morass of the halls of the Missouri Legislature and from trying to understand the quicksand of political influence.

Nurses collectively have viewed power as a dirty word because as a predominately female profession they have followed the dictates of a social system in which they were second class citizens, not only personally but professionally. By adopting such a passive position they have relinquished the ability to speak for themselves and thus have little control of their destinies. There is an increasingly apparent struggle to gain that power which most of us have never had. Some have never wanted it and consequently will never have it but there are a great many of us now who do want to be able to control our own lives rather than delegating that to someone else.

When lobbying it becomes immediately apparent where power is and where it is not. It is with those people who are large in numbers, make contributions of time and/or money and who are assertive and persistent in communications with legislators. Generally, the nursing profession fits only one of those qualifications. Nurses make up a large group of the total population, however, they do not contribute a great deal of money nor time for the care and maintenance of their profession and are generally sporadically aggressive rather than persistently assertive.

It is exceedingly dangerous politically to wait until the last minute to make yourself known and to request assistance from legislators if the same legislators never hear from you at any other time than when you want them to do something. They need to have positive strokes just as you need positive strokes. There is much power in positive stroking and it must be done persistently and diplomatically. Of course you are one stroke ahead of others if you are a voter who exercises that right regularly. Your legislators are very aware of how they were able to be elected and listen to the wishes and needs of the constituency. They will respond all the more readily, however, if you are in contact from time to time with messages regarding the work they are doing, with offers to pass out handbills, with needed information, etc. They work hard and will respond favorably to your diplomatic recognition of that fact. Then when the time comes to ask for assistance you have someone with a ready ear and a willing mind set. There is much power to be gained and maintained in this manner.

There is not a great deal of money contributed by nurses therefore, you probably cannot expect to gain a great deal of power in that manner. Your state nurses associations work very hard in your behalf and money for dues to those associations is well spent. They are well aware of the necessity to gain power and are persistently assertive to your benefit. They can lobby and keep informed on legislative issues which you haven't time to pursue. Let them know where your interests lie and of your concerns. They are most ready, willing, and able to assist you. However, it is very dangerous to passively assume that someone else is going to take care of your problems for you. When you discover the problems are still there and you must do something, then the time is short and you must suddenly become aggressive. This leaves legislators and others puzzled as to where you were all along and why you are just now at this late date becoming excited about an issue which you say is important. It detracts from your credibility a great deal and reduces your power base.

PHILOSOPHY FROM FLO - CON'T

The one characteristic of power that we do have as a profession is that of numbers. Almost 64,000 nurses can pack a large punch, as we have demonstrated in the past. Think of the added power if we possessed all three characteristics or even two. It boggles the mind to try and imagine the changes that would occur in health care, in the profession itself and in the life of each individual nurse. Try it!! You'll like it!!

COMMENTS FROM CAROL

LEGISLATIVE UPDATE

Three bills introduced during this year's legislative session have had a major impact on the Board:

Senate Bill 426; House Bill 1647: These two bills in pertinent part propose to remove proprietary schools of nursing from the jurisdiction of the Board and place them under control of the Coordinating Board of Higher Education. By statutory definition; proprietary schools of nursing would be those located in hospitals. As of this writing, the House Critical Decisions Committee will advance a committee substitute bill which would leave these schools under the jurisdiction of the Board of Nursing

House Bill 1007: This is the Board of Nursing annual appropriations request which grants approval for planned expenditures of the nursing fund. Priority items in this request were the addition of two new staff members to deal with the increasing volume of work generated by a 166% increase in licenses in the past ten years. Complaints against licensees have also risen dramatically during this period, and are expected to continue to increase due to the new Malpractice Law which includes nurses in mandatory reporting provisions. As of this writing, the Governor and the House Appropriations Committee have recommended this request. We will continue to pursue this bill through the system.

It has been heartening to see so many of the nursing groups in the state working together to help the Board in their lobbying efforts. MONA, MOSALPN, MLN, MHA, and ADN Council have all worked diligently in contacting their legislators and/or committee members to express nursing's concern over these issues. We have received many calls in the office from others throughout the state offering assistance. Your hard work and expressions of concern have been recognized and acted upon by those who were contacted.

You have all demonstrated the results of nurse power working through the system. We would like to ask one more thing of all of you who contacted your legislators. Please send a follow-up letter thanking your legislator for his/her support of the Board of Nursing amendment to Senate Bill 426. They did a good job for us, and we owe them recognition of that fact. If we can assist you with names and addresses of your legislators, please give Flo or me a call. Thank you for your timely support on these important issues.

Thus it seems that what is often referred to as the diploma school representative should probably, more accurately be referred to as "a consumer protector with diploma nursing education experience."

None of the above can be accomplished without the assistance and input from each of you in the nursing community as well as the health care consumer. We welcome it, we value it, and we want it.

Before closing I would like to share with you one of my most impressive and saddening experiences at my first state board meeting. The experience was in learning about the breadth and depth of the problems of the impaired nurse. While this problem is not unique to the nursing profession, it is no less painful to learn that too many of my colleagues are falling helpless victim to this anathema to the practice of nursing. Therefore, I implore each of you to not turn your head or ignore that impaired nurse, instead assist her/him to get help from an impaired nurse program as soon as possible.

My most pleasant experience was to learn that I have been fortunate to join the compassionate, caring, and devoted group of people of the state board who take their job seriously, and who conscientiously go about the task of assuring the protection of **ALL OF YOU, THE PUBLIC.**

****WHAT IS THIS NEWSLETTER AND WHY DID I RECEIVE A COPY OF IT???

The Board of Nursing Newsletter is our main source of keeping you informed of this Board's activities. If you drive from the eastern part of the state via I-70, exit at the Kingdon City, Hwy. 54 West, State Capitol Exit. Proceed to Jefferson City via Hwy 54, West, cross the bridge and take Hwy. 50 West, (Sedalia) Exit. Proceed on Hwy. 50 West to stop light. Turn right. **At the 4-way stop turn left. Pass the Capital Mall, go right on Truman Blvd. Turn left at first street past Exchange National Bank. Take the first right which is North Ten Mile Drive. Professional Registration is located in the first building on the right. It is metal cream colored building.**

If you drive from the western part of the state via I-70, exit at Hwy. 63 South, Jefferson City Exit in Columbia. Proceed into Jefferson City via Hwy. 63 South. After Crossing bridge proceed as described above.

If you drive from the western part of the state via Hwy. 50 East, turn left at the first light after passing city limits sign. Proceed as described above.

POLICIES ADOPTED BY THE BOARD REGARDING SCHOOLS

1. Intermediate Care Clinical Facilities which change to a Skilled Nursing Facility designation do not need to be re-surveyed for approval.
2. The Board will accept Arkansas Psychiatric Technician Nursing Graduates for licensure by endorsement as LPN's if they have entered the program after September, 1981. Graduates of the course prior to this date do not meet Missouri Minimum Standard Requirements for Licensure as LPN's.
3. The Board will no longer accept graduates of the Air Force Medical Technician Course with a graduation date after 1976, as this course was discontinued at that time. There is a course with a similar number but it does not meet the requirements of the Board.
4. Institutions that conduct both professional and practical nursing programs may not share faculty.
5. Any out of state clinical facility that has been approved by that State Board of Nursing will be accepted by the Missouri State Board of Nursing.

*****LICENSE RENEWAL NOTICES*****

Missouri has a mandatory licensure law. Therefore, an individual may not legally practice as a registered professional nurse or a licensed practical nurse in Missouri unless that person has a **CURRENT** Missouri license or valid temporary work permit.

License renewal notices were sent to all current 1985-86 Registered Professional Nurses on March 4, 1986. If you have not received your renewal notice please contact the State Board of Nursing office so that one can be located for you. These notices have been sent to the address as it appears on our records in the office. Registered professional nurse licenses expire on April 30, 1986.

Licensed practical nurse renewal notices are scheduled for mailing on March 29, 1986. If you do not receive a renewal notice by April 15, 1986, please contact the Board of Nursing office so that one can be located for you. These notices have been sent to the address as it appears on our records in the office. Licensed practical nurse licenses expire on May 31, 1986.

INACTIVE STATUS

If a licensee is not working and wishes to be placed on the inactive register, they **MUST** sign the inactive request on the renewal notice and return the entire notice in the envelope that is provided. This request must be postmarked no later than May 31, 1986 for registered professional nurses and June 30, 1986 for licensed practical nurses. For further information contact the Board office.

NOTICE TO EMPLOYERS - LICENSE RENEWAL PROCEDURE

The State Board of Nursing is happy to assist you during the license renewal period. However, we receive an extremely large volume of calls for verification of a current license during this period and at times you might have problems getting through to our office, or not have the appropriate information available at the time of the call for verification. The following steps will assist in verification of licensure:


1. Notify nurses that they must have a current license on May 1, 1986 for registered nurses and June 1, 1986 for practical nurses, or they cannot work after these dates without:
 - a. Proof of a current license
 - b. Telephone verification from the State Board of Nursing.
2. On April 15th for RN's and May 15th for LPN's, please make a list of nurses in your facility who have not shown a current/renewed license for verification.
3. Send the Board office a listing of nurses that have not renewed with their name and license number fifteen (15) days prior to expiration date of license. (We will wait one week and send the listing back to you verifying those that have renewed.)
4. The Board office will keep a copy of the listing. The last day of renewals we will contact your facility and verify those that have renewed and are on computer.
