Should we have mandatory continuing education? Should the Nursing Practice Act include a specified number of continuing education credits in order to be eligible for renewal of one's license to practice? There are arguments both pro and con on that issue.

There are many who argue that, with a profession whose members deal with the critical issues that nurses must confront daily, the safety of the public certainly must be of primary concern. The profession is licensed and regulated for that purpose. Technical advances in medicine are occurring at such a rapid pace that the practice of nursing changes almost from day to day. New techniques, treatments, and medications are developed and introduced so frequently that if one considers the "state of art" 5 years after graduation what one was taught in one's basic nursing education program would appear most inadequate for current practice. Curriculae for all basic nursing education programs are developed to satisfy several needs, one of which is the need that graduates have of passing the NCLEX in order to become licensed practitioners. The NCLEX is based on surveys showing what exists in current practice both for PNs and RNs. From that information test plans are developed which are made available to all nursing education programs to utilize in developing curriculae.

The so-called gap between education and practice which is created by advancing technology must be filled for the safety of clients and nurses alike. So how is that done? Primarily through continuing education! Continuing education may be in-service, conferences and workshops, more formal education offerings or one on one teaching sessions with physicians, more experienced nurses, other kinds of health care practitioners, and lay members of the public, as well as through individual reading and learning situations. There are many ways to continue the learning process.

The Case of Sermchief vs. Gonzales is generally well known and well discussed among nurses. In the decision rendered by the Supreme Court of Missouri in that case it was stated that a nurse may be permitted to assume responsibilities . . . so long as those responsibilities are consistent with her or his "specialized education, judgment, and skill based on knowledge and application of principals derived from the biological, physical, social, and nursing sciences." This statement seems to support the concept of continuing education. Later in that same decision the court continued with the following:

"The broadening of the field of practice of the nursing profession authorized by the legislature and here recognized by the court carries with it the profession's responsibility for continuing high educational standards and the individual nurse's responsibility to conduct herself in a professional manner."

Another statement appearing to support continuing education.

There seems to be no argument against the need for continuing education. The argument begins when the qualifier "mandatory" is added. If safety of

the public is the primary consideration then it seems it should be mandatory in order to assure that all practicing nurses are current in their knowledge and skills. On the other hand, there is not a sufficient body of evidence to show that mandated continuing education prevents incompetent practice. If one is merely attending continuing education offerings in order to comply with the letter of the law in order to renew one's license, the educational offerings attended may be totally inappropriate for the area of practice in which one is currently engaged and thus will accomplish nothing in the way of increasing knowledge relative to current practice.

In conversations with other Executive Directors of states where continuing education is mandatory (there are 20 states that do) it appears that some of the results of requiring continuing education for renewal of licenses are not necessarily desirable. The paperwork and staff time involved in approving, tracking, and verifying continuing education is said to be tremendous. For this office that would mean more staff, more space, more equipment and supplies and therefore higher fees to support all those increases. I understand the management of that process is a headache, almost impossible to get under control.

Because there is no mandate by statute, nurses may obtain continuing education on a strictly voluntary basis. There are employers, however, who require continuing education in order to progress or maintain/retain a position. The Missouri Nurses Association has a very excellent continuing education program which includes approval of continuing education offerings, awarding of CEUs and recording and retention of that information. The court decision in Sermchief vs. Gonzales stated that nurses must act professionally and are responsible for maintaining educational standards. The Missouri Board of Nursing believes that based on that decision and the other above mentioned facts that each individual is responsible for maintaining their own standards of education. Each nurse, in order to fulfill professional responsibility must obtain the most appropriate educational offerings for his/her circumstances and in the most timely manner possible. There are many good continuing education offerings available including those offered by employing institutions. They are a means of improving skills and knowledge and can lead to professional advancement. It's not only professional it's very wise to take advantage of continuing education offerings and there are many available. Continuing education is your individual responsibility, it could keep you out of court, help you be more secure in your job and at the same time assist in networking with others in the profession. All are benefits that far outweigh the cost.

A recent situation suggests that some of our nurse educators may not understand the process by which the Board of Nursing promulgates rules. I'm sure everyone in nursing education is aware that late in 1988 the Board appointed a Task Force to review the Minimum Standards for Accredited Professional Schools of Nursing. The Task Force's function was to review the existing standards and to determine if clarifying language could be added which would better assist schools in interfacing with the Board of Nursing. The membership of the committee was comprised of three Board members and a fourth ex-officio Board member. In addition, educators representing three levels of nursing education were voting members. The Board counsel and staff were non-voting members. The group came to an early conclusion that most of the existing standards needed to be rewritten for clarity and accuracy. Two long years later the Task Force was ready to share its rough draft copy of the proposed revisions of the Minimum Standards with the nursing education community. Copies were mailed to all of the generic schools of nursing for their input.

The response from nursing education was welcomed and appreciated however, it was during this experience that many questions were asked which indicate a need to review the rule-making process in order to dispel misunderstandings regarding how a proposed rule becomes an official rule.

In this particular situation, the Task Force for revision of Professional Minimum Standards was Board appointed and charged with the responsibility to conduct the process of reviewing and revising the Minimum Standards. Even though there are Board members on the Task Force the undertaking is not being conducted as a part of the Board's activities. The committee will present their final proposed revisions to the Full Board with a recommendation that the Board of Nursing accept the rewritten document. The Full Board will either accept the recommendation, revise the document or reject the document.

If the Full Board accepts the proposed document the proposed rule moves into the process of rule-making. The process begins with the printing of the proposed rule in the Missouri Register. Once the Missouri Register has been published there is a thirty day official comment period. Reactions to the proposed rule come to the Board office and are accumulated until the expiration of the comment period. Responses are then presented to the Board at their next meeting and each will be discussed and considered with regards to what actions shall be taken. The Board has the final decision whether to file the Final Order of Rule-Making or withdraw the proposed rule. If the Board votes to file the proposed rule it is again published in the Missouri Register along with a synopsis of the comments that were submitted and the Board's subsequent actions in response to the comments. After the rule is published in the Code of State Regulations it becomes official. A rule which is filed as an emergency is treated in a slightly different manner. You may request a copy of the specifics of filing an emergency rule from the Secretary of State's office.

The process of creating a new rule or revising an existing rule does not require the appointment of a task force. Likewise, the decision to disseminate a draft copy to the nursing community is arbitrary; it is not mandatory. The

Board of Nursing has chosen to make information regarding proposed changes or new rules available to those involved with the education of nurses. In this manner the Board provides for educators to submit enlightened comments that may reveal unforeseen areas of negative impact. However, only the publishing of a proposed rule in the Missouri Register is required.

This is how a proposed change or a new rule comes into being!

To conclude the saga of the revisions of Professional Minimum Standards I will notify the nursing education community when the proposed rule on professional Minimum Standards is published in the Missouri Register. Comments can once again be presented to the Board. However, I would suggest that nurses become informed as to where they can access the Missouri Register on a regular basis. There are groups with authority to promulgate rules appropriate for their needs that may negatively impact upon nursing. The Missouri Register is the vehicle by which nursing can monitor all state agencies who make regulatory rules. Any one can subscribe to the Missouri Register by submitting a letter of request to the Secretary of State's office. A year's subscription of 24 issues is \$56.00. However, there may be a copy at your local library that is available for your review. I am providing a list of libraries that subscribe to the Missouri Register in this Newsletter. If this does not assist you, a copy of the complete mailing list can be obtained from the Missouri State Library or the Missouri State Archives. The mailing list will inform you as to where the Missouri Register is mailed on a regular basis.

Notice: The Administrative Rules Division will edit the rules to eliminate legalese. The Secretary of State is given the authority to correct typographical or spelling errors in the publication of any rule. However, after a document has been filed for public inspection and publication, a substantive error in the text may be corrected only by the filing of another document making the correction.

Prior to publication, rules will be reviewed by a staff member of the Administrative Rules Division. If errors are found, an agency representative will be contacted. If minor, the changes may be made informally, or otherwise the document may be returned to the agency for failure to comply with the format.

If a typographical error appears in the Missouri Register or the Code, it shall be corrected if the Director of the Administrative Rules Division determines the error would confuse or mislead the reader or the error would affect the substantive text of the rule.

Male Nurses and Licensure Discipline

As most of you know that have read any of the previous Newsletters, the primary problem facing the Missouri State Board of Nursing in the area of complaints and discipline is substance abuse. In researching approaches utilized by the Board over the last few years, some interesting results were discovered.

The number of male nurses disciplined by the Missouri State Board of Nursing is disproportionately higher than for female nurses. For example, while 4% of Missouri's approximately 77,000 nurses are male, 20% of the disciplinary actions taken by the Missouri State Board of Nursing have been against male nurses. Unique to Missouri? Not at all.

Figures from the National Council of State Boards of Nursing (NCSBN) indicate nationally 3% of nurses from 1985-1988 were male. However, during that same period of time 18% of the disciplinary cases submitted to NCSBN were male nurses.

What makes male nurses more likely to be disciplined than female nurses? Some writers suggest that male nurses are still somewhat unique to our profession and therefore are scrutinized by their female peers closer than female nurses. Others relate the number of chemical dependency complaints to certified registered nurse anesthetists (CRNAs) who are predominately male and known to be at increased risk for the development of this disease. Perhaps it is related to society's acceptance level of male nurses, as patients view the care male nurses provide differently than female nurses.

The nursing profession has strived to recruit more men into nursing over the past several years. Some researchers believe men have been swayed into nursing to assist this predominately female profession in advancement of wages, cohesiveness, leadership and image.

The NCSBN hopes to address a portion of this phenomena in it's proposed research. However, additional research is warranted to learn what is causing this disproportionate discipline of our male colleagues.

ADVANCED PRACTICE TASK FORCE UPDATE

Due to the amount of comments received the Missouri State Board of Nursing's Advanced Practice Task Force is continuing in its efforts to provide a statement that will best serve the public and the profession. During the April, 1991 Board meeting the Board approved the following Statement to be filed with the Secretary of State's office as a proposed rule. No date has been set at this time for that filing.

Advanced Registered Professional Nursing Position Statement

Purpose: To specify the qualifications necessary for a nurse to use certain specialty titles and to protect the public from misrepresentation concerning the nursing profession.

1. No nurse shall use the following titles or abbreviation of those titles unless they meet the criteria stated:
 - A. Certified registered nurse anesthetist -- must be a registered nurse and hold current certification by the national certifying body of the American Association of Nurse Anesthetists.
 - B. Certified nurse midwives -- must be a registered nurse and hold current certification by the national certifying body of the American College of Nurse Midwives.
 - C. Certified nurse practitioner -- must be a registered nurse and hold current certification in the area of nursing specialty practice by the national certifying body of: (1) NAACOG Certification Corporation as an OB/GYN nurse practitioner or neonatal nurse practitioner; or (2) the American Nurses Association as a family nurse practitioner, or adult nurse practitioner, or pediatric nurse practitioner, or school nurse practitioner, or gerontological nurse practitioner; or (3) the National Certification Board of Pediatric Nurse Practitioners and Nurses as a pediatric nurse practitioner.
 - D. Clinical nurse specialist -- must be a registered nurse and have a master's degree in the area of clinical nursing specialty practice or be currently certified by the American Nurses Association as a Clinical Nurse Specialist in the area of specialty practice.
2. Use of the title certified registered nurse anesthetist, certified nurse midwife, certified nurse practitioner or clinical nurse specialist without meeting the requirements set forth in Paragraph 1 is a misrepresentation in the performance of the functions or duties of a licensed professional or practical nurse and is grounds for discipline under Section 335.066.2(5), RSMo 1986.

In an attempt to further help the public and the profession understand the goal of this Statement a Position Paper was formulated.

Advanced Registered Professional Nursing Position Paper

Advanced Nursing Practice

The State Board of Nursing established the Task Force for Advanced Practice in October, 1988, for the purpose of determining the need for statute change or rules and regulations relating to advanced nursing practice. The first meeting of the Task Force was in January, 1989, and it has met at approximately 3-month intervals since that time. The Task Force has been comprised of individuals from the State Board of Nursing, an assistant attorney general and individuals from advanced nursing practice including a certified family nurse practitioner, a certified pediatric nurse practitioner, a neonatal nurse practitioner, a certified nurse midwife, and a certified nurse anesthetist. The Task Force has included representation from the Missouri Nurses Association, NAACOG (The Organization for Obstetric, Gynecologic, and Neonatal Nurses), the National Certification Board of Pediatric Nurse Practitioners and Nurses, and the Missouri Association of Nurse Anesthetists.

The primary nursing concern has come as a result of registered professional nurses functioning in advanced nursing practice roles without demonstrating the appropriate educational preparation and/or certification for that specialty role. The State Board of Nursing has had limited success in disciplining those individuals or limiting the scope of practice for those individuals. In order to protect the public and to address this problem, the State Board of Nursing established the Task Force for Advanced Practice to study the issue and to make recommendations.

Sermchief v. Gonzales

The Supreme Court opinion of Sermchief v. Gonzales affirmed a broad interpretation of the Nursing Practice Act. The opinion reads as follows, "We believe this phrase evidences an intent to avoid statutory constraints on the evolution of new functions for nurses delivering health services. Under 335.016.8, a nurse may be permitted to assume responsibilities heretofore not considered to be within the field of professional nursing so long as those responsibilities are consistent with her or his "specialized education, judgement and skill based on knowledge and application of principles derived from the biological, physical, social and nursing sciences." The opinion goes on to point out the responsibility of the profession to maintain high education standards and of the individual to obtain the necessary education and to know one's limits. The opinion states, "The broadening of the field of practice of the nursing profession authorized by the legislature and here recognized by

the Court carries with it the profession's responsibility for continuing high educational standards and the individual nurse's responsibility to conduct herself or himself in a professional manner. The hallmark of the professional is knowing the limits of one's professional knowledge."

Clearly there are advantages to the broad Missouri Nursing Practice Act, which allows for the evolution of nursing practice. This broad permissive wording in the law however lends itself to a dilemma. While it is important that the statute or rules and regulations allow the profession of nursing to continue to grow and evolve as societal needs change, it is equally important that the public be protected from individuals who might practice beyond their knowledge and skill level. The professional association sets the standards for excellence in practice and the State Board of Nursing has the legal authority to set minimum standards for competence as a registered professional nurse. Unlike other professions, there are limited built-in controls for scope of practice for registered professional nurses in primary care arenas. For example, the scope of practice for physicians is limited by requirements for hospital staff privileges and to some extent the cost for liability insurance coverage. These societal reviews do not exist in such a way as to control scope of practice for registered professional nurses as primary providers. Registered Professional Nurses who provide primary care services do not generally have hospital privileges. While the cost and requirements for liability insurance are increasing for nurses in advanced practice, those requirements are not limiting nurses in advanced practice.

The first meetings of the Task Force dealt with the definition of advanced nursing practice and a review of other statutes and rules and regulations of seventeen (17) other states related to advanced practice. Initially the Task Force attempted to define advanced practice to include clinical as well as advanced nursing practice in education, administration and research. It then became evident that the current and pressing questions from those outside of the profession regarded the legality, scope of practice and appropriate education and certification related to advanced practice roles in which the nurse is the primary care provider. (These would include such roles as, nurse practitioner, nurse midwife, nurse anesthetist and clinical nurse specialist). In addition, a review of statutes and rules and regulations of other states demonstrated that the definition of advanced practice most often included nurse practitioner, nurse midwife, nurse anesthetist, and clinical nurse specialist. Thus, the advanced practice statement developed by this task force addresses nurse practitioners, nurse midwives, nurse anesthetists, and clinical nurse specialists and not advanced practice in education, administration and research.

Educational Preparation for Advanced Nursing Practice

The nursing profession is moving in the direction of requiring the Masters Degree in Nursing for the advanced practice roles. For example, by 1992 the American Nurses Association will require the Masters Degree in Nursing for the family, pediatric, adult, gerontological, and school nurse practitioner in order to sit for the certification examination. The National Certification Board of Pediatric Nurse Practitioners and Nurses will also require a Master's degree beginning in 1992. Nurse anesthetists require successful completion of a

program in nurse anesthesia which is accredited by the Council on Accreditation Nurse Anesthesia Program. Graduates must pass the national certification exam of the Council on Certification of Nurse Anesthetists and must be recertified every 24 months by the Council of Recertification of Nurse Anesthetists. By 1998 entry level into nurse anesthesia must be at the master degree level. Nurse midwives require an advanced formal education and certification. Levels of education are basic certification, masters degree or doctorate degree in midwifery. The clinical nurse specialist, by definition, is a masters degree in clinical nursing.

As with advanced graduate education in any profession, the Masters degree in Nursing provides additional quality assurance to the public.

The Task Force and the State Board of Nursing support this movement toward the requirement of the Masters Degree in Nursing for advanced nursing practice roles. However, the history and evolution of other advanced nursing practice roles has presented opportunities for registered professional nurses to prepare for advanced nursing practice roles by completing advanced formal educational programs in the specialty area conducted within institutions of higher education. For this purpose, the term advanced formal education program is defined as a program which prepares the practitioner to sit for a national certifying examination in a specialty area or complies with educational standards set by national nursing certifying organizations. Those individuals who complete the advanced formal education program then may become certified through the appropriate national nursing organization. The advanced practice statement has recognized those individuals who have completed advanced formal education programs and have completed certification in their specialty area through the appropriate national nursing organization.

Certification

The Task Force and the Board of Nursing believe that certification by a national nursing organization is critical in order to provide the level of professional review necessary for advanced nursing practice. The process of certification by a national nursing organization provides controls on educational standards, testing procedures and practice requirements necessary for quality assurance to the public. Therefore, the article, "56 Ways to get Certified" American Journal of Nursing, March 1990, was reviewed by the Task Force to identify those specialty areas which require either the Masters Degree in Nursing and/or certification by a national nursing organization following the completion of an advanced formal education program in the specialty area.

The national certifying bodies recognized by the Task Force include:

1. Council on Certification of Nurse Anesthetists;
2. American College of Nurse Midwives;
3. American Nurses' Association (clinical nurse specialist and nurse practitioner level certification only);
4. NAACOG Certification Corporation (OB/GYN and Neonatal Practitioner level certification only); and
5. National Certification Board of Pediatric Nurse Practitioners and

Nurses.

In their discussions, the Task Force attempted to differentiate between advanced roles and expanded roles. Advanced nursing practice roles are those roles in which one uses skills gained through a Masters Degree in a clinical nursing area or advanced formal education in a specialty area and certification in the specialty area. Expanded roles occur as a result of an expansion of clinical expertise gained from on-the-job experience, in-service education, and continuing education programs. The attachment lists those certification programs for advanced nursing practice discussed in the Advanced Nursing Practice Statement.

The State Board of Nursing has the authority to enact rules relative to advanced practice as it relates to misrepresentation in the performance of the functions and duties of licensed nurses. The Board has the authority to enact rules relating to the practice of two levels of nursing, licensed practical nursing and registered professional nurses; advanced practice is part of professional nursing. The Board can establish what would be misrepresentation to the public.
