REMINDER: Do I Need a Bureau of Narcotics and Dangerous Drugs (BNDD) Number?

The February, March, April 2001 issue of the Missouri State Board of Nursing Newsletter discussed controlled substance regulations that went into effect on November 30, 2000. Some of these regulations may necessitate licensed nurses securing a

BNDD number.

In particular, you will want to review 19 CSR 30-1.066 Dispensing by Individual Practitioners, which provides the conditions under which licensed nurses must have a BNDD number to administer or dispense controlled substances from an individual practitioner's inventory.

Please review the Practice Corner article in the February, March, April 2001 issue and/or contact the Bureau of Narcotics and Dangerous Drugs at 573-751-6321 to ensure your compliance with the regulation if applicable to your practice.

Failure to comply with applicable state laws may result in a complaint against your nursing license and possibly subject your license to discipline by the Board.

If You Need to Request a Specific Opinion of the Board

Pursuant to 536.010 (4)(b), RSMo, the Missouri State Board of Nursing may issue "an interpretation...with respect to a specific set of facts and intended to apply only to that specific set of facts."

Sometimes an individual or a facility may need or want a formal opinion or decision from the Board of Nursing regarding a specific practice matter because of certain characteristics of the matter itself or due to the nature of circumstances within which particular practice inquiries arose.

When a written opinion or decision of the Missouri State Board of Nursing is requested regarding a specific practice inquiry, the process is as follows:

1. The Board's Practice Committee members first address the written request.
2. The Practice Committee members review the specific practice inquiry, attached documents, and any testimony provided during the scheduled Practice Committee meeting, and, following membership discussion, make their recommendations to the Full Board.
3. During the next Full Board meeting that follows the meetings of the Practice Committee, the Full Board reviews all Practice Committee recommendations and renders final Missouri State Board of Nursing opinions or decisions.

Should you need to secure a written opinion from the Board regarding a specific practice matter, you will want to utilize the following document to organize your specific request and supply pertinent information to assist the Board in its deliberations. If you elect not to request a specific opinion from the Board, you will find the following document to be an assistive guide to your own scope of practice decision-making. It will be important to review the statutes, 335.016 (9), RSMo (licensed practical nurse) or 335.016 (10), RSMo (registered professional nurse) regarding authorities granted to your license.

5. What is the accepted standard of practice in your locale/area of the state in reference to this particular situation (based, for example, on contacts you've made with other comparable institutions or entities)?

7. Please add below or include in your mailing, any additional information* that has not been addressed and that you believe would assist the Board in responding to your request.

In last quarter's newsletter, in the first of a three part series, I discussed sections 335.066.2(1), (5), (12) and (14), RSMo, of the Nursing Practice Act, as those subsections related to the use of drugs and alcohol. In this article, I will examine in greater detail subsections (5) and (12) and also review subsections (6), (10) and (15) in order to clarify how these provisions relate to nursing conduct.

The language of the relevant provisions is listed below:

335.066. Denial, revocation, or suspension of license, grounds for, civil immunity for providing information. -

1. The board may refuse to issue any certificate of

registration or authority, permit or license required pursuant to sections 335.011 to 335.096 for one or any combination of causes stated in subsection 2 of this section. The board shall notify the applicant in writing of the reasons for the refusal and shall advise the applicant of his or her right to file a complaint with the administrative hearing commission as provided by chapter 621, RSMo.

2. The board may cause a complaint to be filed with the administrative hearing commission, as provided by chapter 621, RSMo, against any holder of any certificate of registration or authority, permit or license required by sections 335.011 to 335.096 or any person who has failed to renew or has surrendered his or her certificate of registration or authority, permit or license for any one or any combination of the following causes:

....

(5) Incompetency, misconduct, gross negligence, fraud, misrepresentation or dishonesty in the performance of the functions or duties of any profession licensed or regulated by sections 335.011 to 335.096;

....

(6) Violation of, or assisting or enabling any person to violate, any provision of sections 335.011 to 335.096, or of any lawful rule or regulation adopted pursuant to sections 335.011 to 335.096;

....

(10) Assisting or enabling any person to practice or offer to practice any profession licensed or regulated by sections 335.011 to 335.096 who is not registered and currently eligible to practice pursuant to sections 335.011 to 335.096;

....

(12) Violation of any professional trust or confidence;

....

(15) Placement on an employee disqualification list or other

related restriction or finding pertaining to employment within a health-related profession issued by any state or federal government or agency following final disposition by such state or federal government or agency.

As you can see, subsection (5) consists of six types of conduct that are prohibited if the conduct occurs in the performance of the functions and duties of a nurse. Because each of the terms listed in subsection (5) has specific legal meaning, each term is set forth below (Please keep in mind that the examples listed below are not all inclusive and that conduct may violate more than one element of (5) depending on the nature and severity of the conduct):

Incompetency occurs when a nurse either lacks or fails to use his/her nursing abilities and knowledge. Examples of incompetency include, but are not limited to, medication errors, pre-charting the administration of medications and treatments, inadequate documentation, failing to follow physician orders properly, violating facility policy, or practicing on a lapsed license.

Misconduct occurs when a nurse intentionally engages in wrongdoing. Examples of misconduct include, but are not limited to, misappropriating medications from the place of employment, knowingly administering medications without a physician's order, knowingly practicing beyond the nurse's scope of practice, or abusing a patient.

Gross Negligence occurs when a nurse is consciously or recklessly indifferent to a professional duty. Examples of gross negligence include, but are not limited to, knowingly failing to provide required medications or treatments, or knowingly not responding to patient needs.

Fraud occurs when a nurse intentionally misrepresents the truth in order to benefit from the misrepresentation. Examples of

fraud include, but are not limited to, forging prescriptions or falsifying a time card.

Misrepresentation occurs when a nurse communicates a falsehood with the intent and purpose of deceit. Examples of misrepresentation include, but are not limited to, practicing and titling as an advanced practice nurse without a Document of Recognition from the Board or lying to an employer in order to continue working as a graduate nurse after the ninety day exemption period has ended or the nurse has failed the examination.

Dishonesty occurs when a nurse demonstrates a lack of integrity or a disposition to deceive. Examples of dishonesty include, but are not limited to, documenting blood sugar values without having performed the test or stealing hospital property.

When a licensee violates subsection (5), the licensee's conduct may also violate subsections (6), (10), (12) or (15). Subsection (6) allows for discipline if a licensee violates any part of the Nursing Practice Act or the rules governing the practice of nursing. A violation of subsection (6) usually occurs when a nurse practices on a lapsed license; because an individual cannot practice or title as a nurse in Missouri without a license. The requirement for licensure is included in sections 335.016(6) and (10), 335.056, 335.076(3), and 335.086(3), RSMo. So you can see that practicing or titling as

a nurse without a valid current license would violate multiple provisions of the Nursing Practice resulting in cause to discipline under subsection (6). A violation of subsection (6) also may result if a licensed practical nurse provides intravenous fluid treatment without proper certification in violation of 4 CSR 200-6.010.

In addition to subsection (6), subsection (10) may be violated if a nurse allows another individual to practice without a valid current license. As a result, supervisors should always be diligent in ensuring that the nurses at his or her facility have valid current licenses and that graduates do not work beyond the graduate nurse exemption period specified in 4 CSR 200-4.020(3) and 4 CSR 200-4.021. Always keep in mind that as professionals we are ultimately responsible for being aware of the law and will be held accountable for our actions.

As you can see in subsection (15), anytime a licensee is placed on an employee disqualification list or similar restriction related to employment in a health-related profession the Board may pursue discipline against the licensee. This is a new provision that was added to the Nursing Practice Act in 1999.

Finally, as we discussed in last quarter's newsletter, licensees are always responsible for being safe and competent practitioners. Nurses have a professional trust confidence with their patients, employers and colleagues. Anytime that trust and/or confidence is violated, the nurse may be in violation of subsection (12) in addition to possibly violating other provisions within 335.066, RSMo.

Again, I hope this discussion helps all nurses to better understand how their conduct relates to the Nursing Practice Act. In the final article, I will review subsections (2), (3), (8) and (11) in order to help you better understand how those provisions are enforced.

• Revised Minimum Standards

Minimum standards are the state rules which define requirements for initial and continued approval by the Missouri State Board of Nursing. Because nursing is dynamic and rapidly

evolving, the Board convenes a task force every five-years or more frequently, if necessary, to review the minimum standards for nursing programs. The task force includes members of the Board's Education Committee and diverse representation from nursing education and service. We are in the process of changing the rules to reflect what the statutes indicate. The word "accreditation" has been changed to "approval" in the Minimum Standards. This is only a language change and not a rule change. The revised minimum standards became effective May 30, 2001. The Minimum Standards may be downloaded from the Missouri State Board of Nursing's web site, or you may call our office and request a copy.

• Deaconess College of Nursing

At the March 14-15, 2001 Board meeting, the members of the Missouri State Board of Nursing approved Deaconess College of Nursing, St. Louis, to implement a one plus one online program leading to a Licensed Practical Nurse certificate with an additional two semesters of study leading to the Associate of Science in Nursing (ASN) degree. Students, at the time of entry to the college, would have the option of declaring the LPN certificate program or the ASN online degree program as their terminal goal. North Central Association reviewed the programs on April 23 and 24th, 2001.


• Lester L. Cox College of Nursing and Health Sciences

At the June 5-7, 2001 Board meeting, the members of the Missouri State Board of Nursing approved Lester L. Cox College of Nursing and Health Sciences to establish two new entry-level nursing education programs leading to eligibility for graduates to write the NLCLEX-RN®. These proposed nursing education programs are: 1) a generic baccalaureate (BSN) nursing program; and 2) an accelerated baccalaureate entry program in nursing (BEPN) for select students who hold prior baccalaureate degrees from regionally accredited colleges/universities.

• Nevada Regional Technical Center

At the June 5-7, 2001 Board meeting, the members of the Missouri State Board of Nursing approved Nevada Regional Technical Center, Nevada, to offer a Practical Nursing Program

via the Internet as a pilot program. This program will offer courses that are already given in real time to students in the program. Curriculum and course outlines are already in use and approved by the Missouri State Board of Nursing and the Department of Elementary and Secondary Education.

Decline in Number of RNs Licensed in Missouri


As of January 1, 2001 there were 75,207 RNs licensed in the State of Missouri with a license expiration date of April 30, 2001. As of June 21, 2001, there were only 68,293 RNs licensed in the State of Missouri with a license expiration date of April 30, 2003. This represents about a 10% decline in the number of Registered Nurses licensed to practice in this state.

Background Checks Required for Nursing License

An applicant for a Missouri license by endorsement or exam is required to provide two completed fingerprint cards in order to conduct background checks with the Highway Patrol and FBI. **It takes about three (3) months to receive background check results.** Exam applicants should apply for a license at least three months prior to the graduation date in order to prevent delays. The Board of Nursing will not authorize a person to take the licensure exam until both background checks are received.

Prints may be taken by any law enforcement official trained in taking fingerprints. A fee is occasionally charged. Licensure Section staff of the Board of Nursing are also trained to take prints. The signature of the person taking the prints must appear on the fingerprint cards. **If reprints are required, a different individual than the one who originally took the prints must take them.**

Most fingerprints fall into the patterns shown below:



Prints must be rolled from nail to nail and the ridges should be sharp and distinct.

Cards must carry the complete PHYSICAL DESCRIPTION of the applicant, including sex, race, color of eyes and hair, height, weight, date and place of birth and signature in ink. Abbreviations for hair and eye color may be used; please use BLK (Black), BLND (blonde), BL (blue), BRN (brown), GRN (green), GRY (gray), and HZL (Hazel). The applicant must also indicate his/her social security number on the card. Cards cannot be properly indexed by the Missouri State Highway Patrol and FBI without this information. Incomplete cards will be returned to the applicant.

The most common reasons for returning a fingerprint card to a person to be re-printed, in order of priority follows.

- 1) Prints were not rolled from nail to nail.
- 2) Prints were not fully inked.
- 3) Missing physical description.
- 4) Missing identifying information (social security number, name, date of birth and place of birth).

VERIFICATION OF A LICENSE

You can verify licenses on-line at www.ecodev.state.mo.us/pr. Click on LICENSEE SEARCH. You can search by name or license number. The search results will display the licensee's name, city, state, license number, original license issue date and license expiration date.

If you have a list of nurse licenses that you would like verified, you can send the list to our office electronically. We will match the list with our database and send the results back to you electronically. Your list needs to be an Excel document or a text file (tab or comma delimited). It should contain the nurse's name and license number. E-mail the list to nursing@mail.state.mo.us.

In order to verify licensure, ask to see an original current Missouri license or temporary permit before the employee reports to orientation. A temporary permit will have a raised Board seal. A license will have the expiration date, profession and license number. The license number could be the profession code (RN or PN) followed by a 6-digit number or a 10-digit number, which consists of the year of license followed by a 6-digit number. Example of a 6-digit license number could be RN060619. An example for the 10-digit license number is 2000134178. When requesting verification from our office, you must provide the complete license number, which includes the year of license.

The name, address and licensure status of all currently licensed nurses is public information. If you have any questions, please call the Board office or use the web to verify credentials **before hiring**. Graduate Nurse Practice The Rule

State Regulation 4 CSR 200-4.020 (3) reads: "A graduate of a nursing program may practice as a graduate nurse until s/he has received the results of the first licensure examination taken by the nurse or until ninety (90) days after graduation, whichever first occurs."

Missouri does not issue a graduate temporary permit, however, if the individual qualifies s/he may practice as a graduate

nurse under 4 CSR 200-4.020 (3).

The graduate must cease practice as soon as s/he fails the exam or 90 days after graduation, whichever is first.

We recommend that you have the graduate sign an **Authorization to Release Confidential Information** form so we may provide you with periodic updates on the person's exam and licensure information. A sample authorization form is included with this article.

After the Examination

Graduates applying for an original license by exam in Missouri will be licensed automatically upon receipt of passing results provided all other licensure requirements are met. When results are received, the successful candidate will be sent the results and a "pass" letter authorizing the person to practice until

the license is received.

There is a thirty (30)-day grace period for graduates who have successfully passed the first available licensing examination in another state following graduation to obtain a temporary permit or license in Missouri after the graduate has received his/her results. Graduates applying for endorsement to Missouri should begin the Missouri licensure process immediately following graduation. As soon as the graduate receives passing results, the graduate should forward a copy of the results to our office so we can issue a temporary permit. A temporary permit cannot be issued until another state has issued the applicant the authority to practice in that state.

About Orientation

Orientation is considered to be employment. Any nurse in

orientation must have either a valid Missouri temporary permit or current Missouri license. The only exception to this policy is if the nurse is practicing under an exemption as listed in Chapter 335.081 of the Missouri Nursing Practice Act or under State Regulation 4 CSR 200-4.020 (3).

Proper Supervision

According to 4 CSR 200-5.010 (1), proper supervision is defined as, "the general overseeing and the authorizing to direct in any given situation. This includes orientation, initial and ongoing direction, procedural guidance and periodic inspection and evaluation."

NCSBN Responds to the Nursing Shortage

The 50 states and territories which comprise the NCSBN, and of which Missouri is a member, are collectively trying to act within statutory authority to address the shortage as presented in the following article. (MSBN)

CHICAGO, IL (JANUARY 29, 2001) - The National Council of State Boards of Nursing (NCSBN) understands that the need for public protection through regulation has never been greater, due in large part to the nursing shortage. Failure to maintain standards of practice could lead to an increase in errors, increased risk for patient harm, and a lack of public confidence.

During shortages of health care professionals, one potential and predictable policy direction is to deregulate, thereby reducing practice standards. As the primary mission of NCSBN's member boards of nursing is protection of the public's health and safety, any such trend of deregulation is assumed to increase the risk of harm to patients. Therefore, the nursing regulatory community is actively working to assure an adequate supply of competent licensed nurses through a number of initiatives. Boards of nursing will:

- Participate strategically at state and national initiatives created to address nursing supply and demand issues.
- Influence national, state and local efforts to improve patient safety in health care.

- Continue timely, humane and effective intervention when state nurse practice acts are violated.
- Support regulatory authority over nursing scope of practice.
- Maximally utilize current categories of nursing and unlicensed assistive personnel without lowering standards and in accordance with regulations.
- Track workplace-related complaints and issues brought to the attention of boards of nursing.
- Collect, analyze, and disseminate comprehensive data describing present and future nursing education and practice environments as related to public protection.
- Uphold standards for entry into the profession, including requirements for U.S. licensure for graduates of foreign nursing schools.

An increasingly growing shortage of nurses, anticipated to reach critical proportions by 2010, is a matter of public protection. Inadequate numbers of appropriately prepared professional nurses threatens the nation's health and safety. Factors contributing to this shortage include:

- Aging of both the nurse workforce, and the faculty members preparing the workforce.
- An inadequate supply of young professionals choosing a nursing career (due largely to competing and more attractive career opportunities in other fields).

- Growing concerns over stressful and/or unsafe working conditions for nurses.
- Increasing demand for nursing care, due to aging of the general population and greater need for chronic and community-based care.

NCSBN continues to support the education and licensure of practical/vocational nurses, registered professional nurses, and advanced practice nurses. NCSBN also supports regulatory oversight of nursing assistants and other unlicensed assistive personnel. Coordinated efforts to promote nursing and to ensure an adequate supply of nurses in the future will serve both the public and the nursing profession's best interests.

NCSBN strongly opposes the implementation of any expedient solutions to the shortage that lead to the inefficient and unsafe delivery of nursing care because of the likely adverse impact on public health, safety, and welfare.

Collaboration among those who practice nursing, educate nurses, supervise nurses, and regulate nursing is essential to maintain the public's trust, health, safety, and welfare during the predicted nursing shortage ahead. The NCSBN pledges its support to assist in seeking solutions for the nursing shortage from the perspective of regulatory public protection.
