**#1     20 CSR 2220-6.050 Administration Of Influenza Vaccines By Protocol**  
**20 CSR 2220-6.055 Authorized Non-Dispensing Activities**

Kimberly Grinston provided a verbal report that these two rules will eventually be processed as emergency rules, but first need our Board's approval before they can go to the Board of Pharmacy and Board of Healing Arts Joint Rulemaking Committee, and then be finally approved by each full Board. The Board of Pharmacy's Rule Subcommittee met August 21, 2009, via conference call and, based on comments/suggestions provided during that conference call, the enclosed draft has

been prepared. The rules were provided for the Board's review and further revision. The following revisions were discussed/recommended:

**20 CSR 2220-6.050 Administration Of Influenza Vaccines By Protocol**

Discussion was held and suggested revisions/comments included:

1. (6) should be changed to (5).
2. (5)(B) – is this a Board of Healing Arts requirement?
3. (7)(B) – whole paragraph should be reworded
4. (7)(C)2. – “of” should be changed to “after” in the second to last sentence.

**20 CSR 2220-6.055 Authorized Non-Dispensing Activities**

Discussion was held and suggested revisions/comments included;

1. (5) – the word “of” should be inserted between “practice” and “medicine.”
2. (6) – discussion was held regarding which version of (6) should be used. These changes were offered to the second (6):
3. “or utilizing” should be deleted from first sentence.
4. “Outside a pharmacy setting” should be added at beginning of the last sentence.
5. “in the physical presence and” should be inserted between “work” and “under” in the last sentence.

By consensus the Board approved forwarding the revised draft to the Board of Healing Arts for consideration.
