#1 **Legislation Update** - Kimberly Grinston reported regarding Express Script's proposed changes to Sections 195.070, 195.080, 195.100, 334.747, and 338.100, RSMo. Discussion was held concerning deletion of 2.b. of 195.080, to change the language to limit this only to professions with prescriptive authority; delete "or comparable mid-level practitioner" from 6. and change "located" to "residing". Discussion was held regarding 195.100 and 334.747, and it was suggested that the same comments should be offered as previously noted. Kim reported regarding proposed changes to 338.100, and suggested the Board propose to keep the deleted portion on the third line of 338.100.1, and to change "representations" to "image" in 3. on page 2. It was Board consensus for Kimberly Grinston to communicate these proposed changes.
