### Steps to Renew Your License Online

#### What You'll Need:

- Access to this email (used for registration).
- Your **license number**.
- Your **Social security number**.

#### How to Renew:

1. **Log into your account.**
2. **Find your license and start the renewal:**
  - Click the **three dots** at the end of the row (your screen may look different depending on your device).
  - Click **"renewal application."**
  - If you need to save and exit, access the **"draft application"** under **"My applications"** to continue later.
3. **Printing Your License:**
  - Click the **eye icon** to view and print your license.

#### Continuing Education (CE) Requirements:

- You do not need to submit CE credits at this stage unless you are audited.
