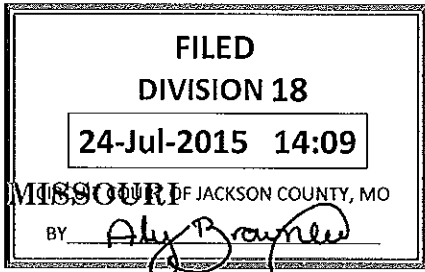

JUDGMENT SUSPENDING PROFESSIONAL LICENSE

On this 22<sup>nd</sup> day of July, 2015 Plaintiff appeared by and through its attorney of record, Assistant Attorney General, Jennifer O. Addadi; Defendant, Donnell Nunn has not answered the petition and has failed to appear after having been personally served and notified of the court date. Based upon the verified petition, evidence adduced and the record as a whole, this Court makes the following findings:

1. This Court has subject matter jurisdiction over this suit and personal jurisdiction over the parties.
2. This Petition is brought pursuant to §454.1003, RSMo., to suspend Defendant's professional license for failure to make child support

payments in accordance with a Court order and for owing an arrearage in an amount greater than three (3) months of child support payments or \$2500 whichever is less.

3. Defendant, Donnell L. Nunn, Social Security No. xxx-xx-5759, is a licensed cosmetologist, Licensee Number 2007008107, in the State of Missouri.

4. Defendant was served personally on June 16, 2015 with the Petition to Suspend Professional License, Notice of Intent to Suspend Professional License (Notice of Intent) and Notice of Case Management Conference for July 13, 2015.

5. As of February 6, 2015, Defendant owed \$35,112.00 in past due support on Jackson County Case Number 0816-FC03005. His monthly support amount is \$456.00 per month.

6. As of February 6, 2015, Defendant owed \$12,090.00 in past due child support on Jackson County Case Number 0916-MC08160 requiring him to pay \$403.00 per month.

7. As of the date Defendant was served with the Notice of Intent, the Defendant owes a child support arrearage that was at least three months of support payments or \$2500, whichever is less.

8. Defendant has failed to pay the entire arrearage stated in the Notice of Intent.

9. Defendant has failed to enter into a payment agreement.

**IT IS THEREFORE ORDERED, ADJUDGED AND DECREED** that suspension of Defendants' cosmetology license, Licensee Number 2007008107 is suspended. Defendant shall refrain from engaging in this licensed activity.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that Missouri Division of Professional Registration and the Board of Cosmetology shall, upon receipt of this order:

1. Determine if the licensing authority has issued a license to the Defendant;
2. Enter the suspension of Defendants license as effective from the date of this Order Suspending License;
3. Issue a Notice of Suspension to Defendant; and
4. If required by law, demand surrender of the suspended license.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that the Missouri Division of Professional Registration and the Board of Cosmetology and Barber Examiners process this order without conducting an additional hearing or review.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that this Courts order suspending Defendants license shall be implemented by the Missouri Division of Professional Registration and the Board of Cosmetology and Barber Examiners and shall continue until they receive notice from this Court that this suspension has been stayed or terminated.



**IT IS FURTHER ORDERED, ADJUGED AND DECREED** that the Missouri Division of Professional Registration and the Board of Cosmetology and Barber Examiners shall not modify, remand, reverse, vacated, or stay this Court's order suspending Defendants professional license.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that the costs of this action are taxed against Defendant.


