**Oklahoma Licensure Requirements**

The State Committee determined the Oklahoma licensure requirements are not substantially the same in the areas of:

Education- No minimum semester hours of practicum/internship; Diagnosis is not a required course of study; and an applicant must complete at least 300 practicum hours.

Supervised Experience – No minimum number of total hours and no timeframe to complete post degree supervision.

Examination – Board is authorized to accept other equivalent examinations as determined by the department and the passing score is not defined within the law or rules.
