Regular meetings are held at the Division of Professional Registration, 3523 North Ten Mile Drive, Jefferson City, Missouri, beginning at 8:30 a.m. each day, unless otherwise designated. Meetings are open to the public, except for discussion of licensure disciplinary problems. A Public Agenda is published for each meeting.

If you drive from the eastern part of the state via I-70, exit at the Kingdom City, Hwy. 54 West, State Capitol Exit. Proceed to Jefferson City via Hwy. 54 West, cross the bridge and take the Hwy. 50 West (Sedalia) Exit. Proceed on Hwy. 50 West to the third stop light, turn right onto North Ten Mile Drive. At the 4-way stop turn left. Our office is located in a metal, cream colored building, approximately .8 of a mile north of the Capital Mall.

If you drive from the western part of the state via I-70, exit at the Hwy. 63 South, Jefferson City Exit in Columbia and proceed into Jefferson City via Hwy. 63 South. After crossing the bridge, proceed as above.

If you drive from the western part of the state via Hwy. 50 East, turn left onto North Ten Mile Drive at first stop light after passing the city limits sign. Turn left at the 4-way stop. Follow this until you reach our building as described above.

If you drive from the eastern part of the state via Hwy 50 West, go all the way thru Jefferson City until you reach the Capital Mall, turn right onto North Ten Mile Drive. Proceed as described above.

If you do not receive a renewal notice by the middle of April, please contact the Board of Nursing office so that one can be located for you. These notices have been sent to the address as it appears on our records in the office. Licensed Practical Nurse licenses expire on May 31, 1985.



*******MANDATORY LICENSURE*******

Missouri has a mandatory licensure law. Therefore, an individual may not legally practice as a registered professional nurse or licensed practical nurse in Missouri unless that person has a current Missouri license or a valid temporary work permit.

*******EMPLOYER*******

It is the responsibility of the employer to verify the authenticity and currency of the license or temporary work permit before employment, as well as during employment. If the individual cannot provide evidence of his/her current license, the Board can verify the current status of a license. We must, however, have the certificate number in order to provide the verification.

The following is the order of **disciplinary proceedings** against nurses in the state of Missouri. As you can see, it takes a long period of time to process a complaint.



Annual Report of the State Board of Nursing

The following information is taken from the Annual Report of the Missouri State Board of Nursing for Fiscal Year July 1, 1983 to June 30, 1984.

SECTION I-Board Activities

1. Members of the Board of Nursing met in five (5) regularly scheduled meetings during the fiscal year 1983-1984, as follows:

One special meeting was held March 8-9 and two (2) telephone conferences, one December 15, and one on February 10, regarding the LPN/IV Rule.

2. The Board met two (2) days for review of test items for the National Council Licensure Exams (NCLEX) to determine if questions are appropriate for beginning level practitioners, if questions are clearly stated and to rate the importance of the particular subject of each individual question.
3. Five thousand sixty-six (5,066) Newsletters were printed and mailed to schools, hospitals, nursing homes, and various agencies and organizations interested in the state of the nursing profession in Missouri.
4. The Board distributed approximately twelve thousand (12,000) copies of the NPA Chapter 335, RSMo. to schools, hospitals, nursing homes, professional organizations, agencies career and employment counselors and all candidates writing the NCLEX examinations.
5. Throughout the year the Board received and responded to twenty-eight thousand, six hundred and eighteen (28,618) pieces of mail. This does not include 60,973 renewals, most of which were handled by the Cash Receiving Room.
6. There were survey visits conducted in thirty-two (32) schools and more than one-hundred twenty-five (125) hospitals or other health care facilities around the state to determine compliance of nursing education programs with the minimum standards for both professional and practical programs.
7. At regular scheduled meetings, the Board reviewed complaints filed against nurses, reviewed applications for examination and interstate licensure and held disciplinary hearings. The following is a summary of activity for the previous fiscal years including fiscal year 1983-1984.




Other Board Action January 21-25, 1985

1. LPN/IV Task Force Recommendations:

After review and consideration of the recommendations made by the LPN/IV Task Force, It was decided by the Board to send random surveys to Home Health Agencies, practicing Registered Professional Nurses and Licensed Practical Nurses in the state of Missouri for their input before a final decision is made regarding the recommendations. The Board will continue the review of recommendations from the task force at the March 6, 1985 Board meeting, and review the information obtained from the additional surveys at the April 8-12, 1985 Board meeting.

2. Presentation from the Advisory Committee for the Missouri LPN/ADN Articulation Project:

It was the decision of the Board that the Advisory Committee for the Missouri LPN/ADN Articulation modules be approved for further implementation by ADN programs.

3. Explanatory Statements/Definitions and Recommendations developed by the MONA Association Council on Nursing Practice:

It was the decision of the Board that they not endorse the statements due to the fact that the State Board of Nursing is a regulatory agency of state government and it would be inappropriate for them to do so. The statement is published by MONA and is not a statement of the Board of Nursing.

NOTE TO APPROVED LPN/IV THERAPY COURSES

LPN renewal licenses will contain the wording IV approved. If you have names that you need to submit as successfully completing an IV Course, please send them in to the Board of Nursing Office as soon as possible so that IV approved will show on the individuals licenses who have completed.

Also, if an approved LPN/IV Therapy Course plans on conducting the course in an institution other than first approved, please notify the Board office so we can verify that the institution is approved. Also, we will need to be notified of faculty changes for these clinical components. All changes from the original proposal need to be submitted in writing to the Board office for approval before initiation.

NOTICE FROM THE BOARD OF NURSING
STATE OF NEW MEXICO

Effective March 1, 1985, New Mexico Board of Nursing will no longer issue temporary licenses "over the counter" (the day the application is brought into the Board office).

All temporary licenses requested will be processed and mailed to the endorsee approximately 3-4 weeks from receipt of the application in Board office. Therefore, nurses wishing to receive a temporary license in **New Mexico** are encouraged to request appropriate forms and submit the completed application fee, etc., to the New Mexico Board of Nursing office allowing sufficient time for processing.

Licensee has abused drugs and alcohol at other locations on various occasions over a period of time.
2. WILLIAM GILES, R.N., 76401, CURRENT 84-85, Springfield, MO. REVOKE. Mr. Giles misappropriated Demerol and Morphine and administered it to himself while working as a Registered Nurse at St. John's Regional Health Center, Springfield, MO. Licensee continued to misappropriate Demerol and Morphine on a frequent and repetitive basis. Licensee falsified hospital records.
3. TERRILEA MITCHELL ANDERSON, R.N., LAPSED 84-85, Galena, MO. REVOKE. While employed as a Registered Nurse at Aurora Community Hospital licensee misappropriated Demerol, Noludar, Vallium, and Placidyl from hospital supplies on a frequent and repetitive basis and while on duty administered it to herself.
4. LEONA HOWARD WENDT, R.N., 57313, INACTIVE 84-85, Owensboro, KY. REVOKE IMPOSITION OF REVOCATION STAYED AND LICENSE SUSPENDED FOR ONE YEAR IMMEDIATELY FOLLOWED BY THREE YEARS PROBATION. While employed as a Registered Nurse licensee took physicians order from her place of employment charging said medication to a patient and charted as being administered.

6. ANNE LOUISE BORGSTROM, L.P.N., 20812, CURRENT 84-85, Independence, MO REVOKED, IMPOSITION OF REVOCATION STAYED AND LICENSE SUSPENDED FOR THREE YEARS. While employed a Licensed Practical Nurse at Independence Sanitarium, licensee diverted Demerol on numerous occasions from hospital supplies for own personal use.
7. ALLENE ALFRETTE RILEY, L.P.N., 14741, CURRENT 84-85, Kansas City, MO. REVOKED, IMPOSITION OF REVOCATION STAYED AND LICENSE PLACED ON PROBATION FOR THREE YEARS. Licensee obtained prescriptions for Preludin 75 from several doctors for weight control program. Licensee falsely represented to each that she had never seen a doctor for a weight control program.
8. LINDA JUERGENS BAKER, R.N., 64701, INACTIVE 84-85, Chicago, IL. REVOKE. Licensee misappropriated narcotics from various employers for personal use.
9. MARIAN YVONNE RANDLE, L.P.N., 13084, INACTIVE 84-85, Council Bluffs, IA. NO FURTHER ACTION AT THIS TIME. In 1977, licensee was convicted in Omaha, Nebraska of assaulting or resisting a law enforcement officer and sentenced to two years confinement in the Nebraska Center for Women.

While employed as a Registered Nurse at Suburban Medical Center, Overland Park, Kansas, licensee diverted Demerol from hospital supplies, and falsified medical records.
12. DAVID ANDREW TIMM, R.N., 81288, INACTIVE 84-85, Oakland, CA. REVOKED, IMPOSITION OF REVOCATION STAYED AND LICENSE PLACED ON PROBATION FOR THREE YEARS. While employed as a Registered Nurse licensee obtained Demerol and Morphine Sulphate from hospital supplies, falsified records, and administered drug to himself.
