DIRECTIONS TO MEETINGS OF THE MISSOURI STATE BOARD OF NURSING

NOTE: Regular Board meetings are held at the Division of Professional Registration, 3523 North Ten Mile Drive, Jefferson City, MO, beginning at 8:30 each day, unless otherwise designated. Meetings are open to the public, except for discussion of licensure disciplinary problems. A Public Agenda is published for each meeting.

DIRECTIONS ARE SUBJECT TO CHANGE DUE TO EXTENSIVE ROAD CONSTRUCTION

If you drive from the eastern part of the state via I-70, exit at the Kingdom City, Hwy. 54 West, State Capitol Exit. Proceed to Jefferson City via Hwy. 54 West, cross the bridge and take the Hwy. 50 West (Sedalia) Exit. Proceed on Hwy. 50 West to the second stop light. Turn right. **At the 4-way stop turn left. Pass the Capital Mall, go right on Truman Blvd. Turn left at first street past Exchange National Bank. Take the first right which is North Ten Mile Drive. Professional Registration is located in the first building on the right. It is a metal cream colored building.**

If you drive from the western part of the state via I-70, exit at Hwy. 63 South, Jefferson City Exit in Columbia. Proceed into Jefferson City via Hwy. 63 South. After Crossing the bridge proceed as described above.

If you drive from the western part of the state via Hwy. 50 East, turn left at first stop light after passing city limits sign. Proceed as described above.

If you drive from the eastern part of the state via Hwy. 50 West, go all the way thru Jefferson City until you reach the Capital Mall. Turn right at stop light. Proceed as described above.

PHILOSOPHY FROM FLO

We were all taught in our basic nursing programs that we must be assertive, be a change agent and an advocate for the rights of the health care consumer. Let me tell you what I see. We didn't learn that lesson! It becomes more evident to me all the time that nurses are generally a passive group of people. It is very obvious politically and may also be true professionally.

You may argue and say to me, "yes, but look how we rally round when there is a crisis, we all go to the capitol building and make loud noises to our legislators when things get really scary". I say to you, "That is an over-reaction to compensate for avoidance behavior. That's "seat-of-the-pants" management-nurses are so very prone to that." Aggressiveness and avoidance/passive behavior are the opposite sides of the same coin. How much better it would be if calm, thoughtful, regular contact was maintained with respective legislators throughout the year rather than waiting until a crisis occurs and over-reacting to the bad feelings caused by the previous passiveness. Calm thoughtful assertiveness is certainly not the same thing as a hurried assault on the Senate chamber.

Recently a legislator expressed to me the opinion that nurses have forever let someone else run their business. They avoid getting involved, don't have time to do any door-to-door campaigning nor the money to contribute to a campaign. They don't keep up on the issues and expect a hand extended to help them up everytime a crisis occurs, although they passively ignore the political scene at all other times.

It's true we have excellent representation by the Missouri Nurses Association at the Capitol building, but again, that's passiveness if we leave all the "politticking" to others. Legislators pay a great deal of attention to their constituents. I receive many phone calls from legislators who have received "a letter" from a concerned constituent and want to follow up and discover the facts.

There are approximately 63,000 registered nurses licensed in the state of Missouri. Just think of the power and influence that could be asserted by that size group of people. Be assertive and take a few minutes to contact your legislators, thank them for past favors and ask how you can help them in return. Next time you have an issue which concerns you, I guarantee your name will be known and the situation will be looked into. That's being assertive! That gets so much better results than hostile, angry aggressiveness which results from an over-reaction to passive behavior. Somewhere we failed to learn a basic lesson in nursing education.

An individual may not legally practice as a registered professional nurse or licensed practical nurse in Missouri unless that person has a current Missouri license or a valid temporary work permit.

1. BARBARA NEELY ANDERSON, R.N., #65374, KANSAS CITY, MO. REVOKED. Licensee misappropriated Demerol from hospital supplies on a frequent and repetitive basis. Diverted the misappropriated Demerol for personal use.

Licensee was terminated for ingesting unprescribed medications while on duty as a registered nurse. Licensee also misappropriated for her own use Tylenol III and Dalmane from hospital supplies.
8. KATHRYN SUE GLASS a/k/a KATHRYN SUE DOSS, R.N., #70131, ST. LOUIS, MO. REVOKED. IMPOSITION OF THE REVOCATION STAYED AND PLACED ON SUSPENSION FOR ONE (1) YEAR IMMEDIATELY FOLLOWED BY PROBATION FOR FIVE (5) YEARS. Licensee on several occasions forged prescriptions to obtain Percodan, Vallium, and Dexedrin.
9. LEEANNA LIVINGOOD HEADD, L.P.N., #29115, ELDON, MO. REVOKED. While employed as a licensed practical nurse licensee misappropriated Tylenol III and Darvon for her own personal use.
10. TERRI JAMES MALONE, L.P.N., #26987, CARUTHERSVILLE, MO. REVOKED. While employed as a licensed practical nurse, licensee removed Vallium from a blister card and administered it for her own personal use. Licensee replaced the Vallium with Lanoxin and Haldol.
11. JUDY LEE BECKER McCANDLESS, R.N., #68763, INDEPENDENCE, MO. REVOKED. On or about October 28, 1983, while employed and on duty as a registered nurse and for about two (2) years prior licensee misappropriated morphine sulfate, demerol, tylenol III and tylenol IV from patient supplies. Licensee misappropriated and ingested controlled substances for her own personal use.
12. CLAUDIA SHARON WASHINGTON, R.N., #69664, BLOOMFIELD, NEW JERSEY. REVOKED. IMPOSITION OF THE REVOCATION STAYED AND PLACED ON SUSPENSION FOR THREE (3) YEARS. While employed as a registered nurse, licensee unlawfully took Demerol and property valued over \$500 from hospital supplies, falsified a controlled substance and syringe count sheet.
