

PHILOSOPHY FROM FLO

The Missouri Nursing Practice Act establishes the Board of Nursing with a stated duty of designating as "accredited" such programs as meet the requirements of the law and the rules and regulations enacted pursuant thereto. One set of rules and regulations promulgated by the Board of Nursing to assist in enforcing the law are called Minimum Standards for Accredited Programs. There are standards for Practical Nursing Programs and for Professional Nursing Programs that are separate and distinct from each other, although they are very similar in wording.

As with all such things, and maybe especially with standards, if not reviewed regularly and appropriate changes made as needed they become useless pieces of baggage. Useless baggage is certainly an apt analogy to use when referring to something which has become outdated and inappropriate, unclear and in part unnecessary. In order to prevent this, they must be reviewed on a regular basis. Toward this end, the Board of Nursing has established a Task Force for studying the Minimum Standards for Professional Programs and is working on reviewing and revising those rules and regulations. There are portions that have become excess baggage. The Minimum Standards for Programs of Practical Nursing will no doubt be considered next.

One particular portion of the current Minimum Standards that has cause for consideration by the Task Force is a section under Conditional Accreditation which states "Programs shall receive a letter of warning when State Board Test Pool Examination failures of first time candidates exceed twenty-percent (20%) and mean scores fall below one (1) standard deviation above the passing score. Two (2) consecutive letters of warning shall result in the program being placed on conditional accreditation status".


One erroneous interpretation of that wording is as follows: because failure rate is the only reason stated in the rules for a program to receive a letter of warning it is assumed to be the only criterion upon which to base the quality of a nursing program. Closely following that conclusion is then the undesirable, educationally unsound idea that one must teach to the exam, and that a particular program is the best by comparison merely because it had a 100% pass rate on the exam. There are several variables to consider when judging quality and to base that judgement on only one would be misleading, certainly uninformed and entirely inappropriate.

I have no intention of giving the impression that the Board of Nursing and staff use only the one criterion of pass rate on exams as the basis for judgement. There are several considerations, none of which are listed in the reasons for issuing a warning in the current rule. Therefore, I believe the emphasis has been strongly and inappropriately placed in the current rule. It

is time to change the rule to reflect reality, to encourage sound principles of education and appropriateness in judging the quality of a program by removing that statement.

Think about it, have an open mind and, if you want to discuss the idea further to help you formulate an opinion, call me.

By the time you read this newsletter, I sincerely hope that all RN's and LPN's who wished to renew their Missouri licenses for the 89-90 renewal period have had success in doing so. The annual renewal period is a very frantic time for all involved, from licensees, to employers, to the Board of Nursing. The Board office receives approximately 200 calls each day with inquiries concerning renewal from around the first of April through the middle of June. And letters, do we get letters ! I'd like to share some of the most common questions and concerns received by this office during the renewal period.

To understand the renewal process, it is important to review a little history. Until the 1982-1983 renewal period, license renewal was a process which each Missouri licensing board accomplished individually. Each board developed their own forms, timelines, policies and procedures to accomplish this annual task. The individual boards mailed out their own forms at a time of their choosing, the forms and fees were received in the office of each board, and licenses were typed and issued by board staff.

In 1981, during the 81st General Assembly, Senate Bill 16 transferred control of the license renewal process away from individual boards to the Division of Professional Registration, where it remains today. It was felt by the legislature that if duplication of services was eliminated, the renewal process would be more efficient. Senate Bill 16 established the following responsibilities for the director of the Division of Professional Registration concerning renewal licensure:

- * The director of the division would establish the renewal dates for each board or commission assigned to the division.
- * The director was authorized to prescribe the forms which would be used for annual renewal by each board.
- * The division would provide the clerical staff and financial management to issue renewal licenses.

The division of professional registration administrative and clerical staff are funded by money appropriated to the division from each licensing board by the general assembly. In simple terms, a portion of the fees collected by each board from its licensees supports the division of professional registration.

Armed with this bit of history, it is easier to understand exactly how annual renewal takes place. The division director establishes the date on which the renewal forms will be mailed to licensees. The renewal form is developed by the division, with input from each board. The renewal notices are mailed out by the division. When an individual licensee mails in the renewal form and check, IT IS NOT SENT TO THE OFFICE OF THE MISSOURI STATE BOARD OF NURSING. Renewal notices and fees are sent to the Cash Receiving Room (CRR) of the Division of Professional Registration. Therefore, when a nurse calls our office and asks if we have received her fee, we are unable to answer that question.

As renewals are received in CRR, they are batched by date received and processed in date order. As envelopes are opened and processed, the clerical staff in CRR will enter onto the computer system the date and amount of fee received, as well as any requested name and address changes. At this point, we do have the capability in the Board of Nursing office to check our computer and see if a fee has been received and a license issued. It is important to keep in mind that Nursing is one of the largest professional boards; therefore, given the staff available to process renewals, it is impossible to open envelopes and do data entry on the same day that they are received. There may be a time lapse of as much as three weeks between receipt of a renewal and data entry onto the computer system. When a nurse requests a name and/or address change, this lengthens the time it takes to process the renewal because of the additional data entry required. During the previous year renewal period, nursing had approximately 15,000 name and/or address changes; many more than any other professional licensing board. This time delay is why the renewal notices this year stated that RN's needed to renew by April 1 and LPN's by May 1, a full month before the expiration of their current licenses. To ease this problem, this year the Board of Nursing expended its funds to hire a full time data entry person to work in the CRR throughout the renewal period to do name and address changes.

Now for some of the most frequent questions:

- Q. Why is the Board of Nursing so slow in processing our renewals this year ?
- A. See above. Additionally, each year the number of licensees increases, necessitating additional time to accomplish the process within the same time frame.
- Q. Why can't you tell me if my renewal has been received ? Why can't you go get it and take care of it now ?
- A. The renewals are not in the Board office. Unopened renewals are sorted by date received, not by license number or name; it would be a needle-in-haystack process to locate a specific renewal in a stack of tens of thousands of unopened forms.
- Q. What am I supposed to do if I don't get my license by the expiration date of my current license ?
- A. If a fee has been received and a license has been or is in the process of being printed, and that data is available to the Board of Nursing office on our computer terminal, we can provide telephone verification of license renewal to a nurse or to an employer. If a nurse requires written proof of current licensure they may request a verification form from our office which is an official document bearing the Board seal indicating that a license has been issued.

- Q. If the CRR doesn't open my renewal until after the expiration date, will I be charged a late fee ?
- A. As long as a nurse has made a good faith attempt to renew, and the renewal is postmarked before the cutoff date, there is no penalty fee. However, if the renewal is not opened, we will be unable to verify a current license. Thus the urging to renew very early so that you will not be caught in a last minute rush.
- Q. What is the Board of Nursing staff doing during the renewal period?
- A. The Board staff is extremely busy answering telephone calls concerning lost renewals, renewals which were not received, mailing duplicate renewal notices, processing late renewals, mailing and processing lapsed petitions for nurses who forgot to renew the previous year, providing licensure verifications for employers and individuals, and dealing with the angry public.
- Q. Why can't the Board of Nursing take back responsibility for processing renewals on its own licensees ?
- A. At this time, Missouri statutes require that renewals will be processed centrally by the division of professional registration. To change this would necessitate a change in the law. It is the right of every citizen of Missouri to contact their legislator with their concerns about the renewal process. Without a change in the law as it currently is written, it is not within the authority of the Board of Nursing to exercise any more control over the renewal process than currently exists.

As a consumer of a state service, it is also your right to forward any concerns or suggestions related to the renewal process to the agency which is accountable for the implementation of this statutory mandate. The creation of this committee grew from a need identified by the Board of Nursing with regards to interpretation of Minimum Standards. It was felt that the Minimum Standards were vague and generally unclear and in some instances, incorrect. Action to explore this further was started more than a year ago. At that time, sections of the Professional Minimum Standards were mailed to professional schools of nursing in Missouri for review and comments. Even though the responses were few, it was the general consensus that there is a need to rewrite the Minimum's rather than revise or attempt to clarify.

It is not the intent of the Board to change Minimum Standards to impact Nursing Education in Missouri, but rather to clarify what is meant by what is written. Some instances of areas needing possible revision are: clinical facility surveys, philosophy and objectives, school visits, faculty qualifications, etc.

Each committee member will review all of the comments which were submitted along with copies of Minimum Standards from contiguous states and other selected states. Areas will be identified that need to be either rewritten or revised.

The committee will meet again June 19, 1989 from 9:30 a.m., to 2:30 p.m., in room 400 of the Harry S Truman State Office Building, Jefferson City, Missouri. The meeting is open to the public and visitors are welcome.

There is presently a high level of interest in developing nursing programs which build upon prior learning. The National League for Nursing recently presented seminar on Educational Mobility, which I was fortunate to attend, focused on the needs for such programs and the problems associated with the development of such program. Dr. Margery Garbin, Vice President for Testing with NLN and Dr. Ann Gothler, Director of Council Affairs, Council of Baccalaureate and Higher Degree Programs with NLN were the workshop presenters. The statement, "Validation of prior learning is a major concern for today's nursing students and faculty", set the parameters of this timely seminar. "Students are actively seeking out programs which will recognize and award credit for prior learning" is evident in recent statistics. However, nurse educators are concerned with the quality and extent of that previous learning. "While educational mobility is a paramount concern, maintaining quality and ensuring academic competency is essential". The seminar's intent was to provide insight to:

1. the need for validation of prior cognitive achievement and clinical performance as a basis for attainment of curriculum outcomes
2. the methods to use in determining student placement
3. the criteria for selecting instruments to assess prior learning and performance

Dr. Margery Garbin began her presentation with statistics that provide evidence that the largest growth in nursing student enrollment is occurring in programs which build on learning that has occurred at a lower level, for example; R.N. into a Baccalaureate program and LPN into an Associate Degree program. The validity of granting credit is a complex issue and can take a chameleon effect when considering the problems of granting blanket credit for previous learning. The following questions must be completely satisfied before blanket credit could be appropriate.

1. the length of the program comparable to the appropriate level of learning?
2. the program's perspective maybe altered by its placement in high school, hospitals or community college?
3. is the curriculum content at the appropriate level?
4. is there a variation in number of credit/course hours? Often there is a high degree of variation in coursework.
5. is there an overlap of criteria
6. does experiential learning plug into identifiable courses of your curriculum?
7. does assessing require some type of evidence/performance.

Dr. Gothler added there is an incredible diversity in nursing education. Programs are diverse in both content and clinical experiences. So you can not accept the idea that you know what type of learning and experiences the student brings with him/her. Gothler added that approximately 50% of all students in professional programs are Licensed Practical Nurses. However, some of them received their education in high schools, others in vocational/technical schools and still others were based in community colleges. It is inappropriate to assume they all had similar educational learning and experiences.

The most difficult problem occurs in the area of clinical experience. Most schools do not identify what is taught and learned in the clinical areas. The following exhibits some of the diversity that occurs in generic nursing programs:

PROGRAMS LEVELS	CLINICAL HOURS
LPN	1300 Average (Range 200 to 1700)
BSN	850 Average (Range 450 to 1300)
ADN	750 Average (Range 400 to 1100)
DIP	1800 Less than (Range 400 to 2700)
BSN (Completion)	60 - 500 Range (May not be supervised)

The inconsistency in clinical hours and content create problems for ladder programs, if such programs do not validate what learning has occurred. One example Dr. Gothler used was the amount of psychiatric experience included in some associate degree programs. In her research she discovered some programs reported six (6) weeks of clinical in this area, however, on closer examination the students had four (4) mornings of observation for six (6) weeks. This could be a major problem for a BSN program who granted blanket credit without validation.

There are external forces which may be influencing the granting of blanket credit. They may be in the form of legislation which makes blanket credit mandatory or the NCLEX test plan may influence blanket credit by the percentages assigned in each division. The American Council on Education evaluates educational experiences in the military and identifies the division and the amount of blanket credit a student should receive.

It is the position of this workshop and the National League for Nursing that validation of prior learning should precede the granting of credit.

FACULTY PLANNING FOR PLACEMENT OF STUDENTS WITH PREVIOUS EDUCATION AND EXPERIENCE IN NURSING

1. take into account the philosophy, purpose and academic
2. review the policies of the institution regarding admission and academic requirement for awarding a degree on the basis
3. consider the purposes, objectives and characteristics of the nursing program and its beliefs concerning individuality of students (liberal versus conservative)

4. develop a plan for evaluation of students' previous learning/experience, both formal and informal, to assure proper placement and progression through a series of varied learning experiences
5. develop a SPECIFIC PLAN (nursing faculty)
 - a. identify the amount of credit in nursing that can be earned through evaluation
 - b. identify in what nursing courses the practice will apply
 - c. decide at what point in the program will evaluation for credit be required
 - d. select methods that can be developed to prepare students for the evaluation, for example, knowledge of the type of validation to be employed such as paper versus performance
 - (1) standardized testing
 - (2) simulation

There are various types of validation approaches. One method is portfolio analysis, standardized testing, clinical examinations, simulations, qualitative analysis and others. Once the method(s) has been selected, it may be decided that the student has a lot of content, but not enough in one or two areas to receive credit. A bridge course may be developed and built into the content that is going to be challenged with validation. In this type of course you provide the new framework and then evaluate the total content that includes the new learning. The bridge course provides the critical elements necessary for the student to make the transition from one role to a higher level while building on the prior learning.

A nursing education seeks to develop methods of attracting/serving today's potential nursing students, they must at least consider educational mobility and analyze how it might work in selected instances. I feel this seminar was syntactical in nature, pointing to the difficulties of developing such an option as well as providing suggestions on how nursing programs might validate the process.

The busy RN and LPN renewal periods, the summer surge of graduate nurses and employers with lethargic licensure verification practices all create opportunities for nurse imposters. The past three to four months have seen an increase in the number of RN and LPN imposters reported to the Board office.

So you think that a nurse imposter would be easy to detect? That's exactly what one Director of Nursing told me when she discovered her newly hired night shift supervisor was a RN imposter. Imagine the shock a physician had when he discovered the "LPN", who had worked for eighteen months as his office nurse, was not licensed. Or, that the Director of Nursing at a facility had never completed a RN program, let alone obtained a license.

There are several reasons why this "scam" can be so successful. Some imposters were nursing students that fell short of completing a nursing program. Others may have been nursing assistants, aides or certified medication technicians for a number of years and feel they have the knowledge and skill level to assume the role of a licensed nurse. No matter what the case may be, if a current license is not requested or verified by an employer, the opportunities are endless for the imposter.

Every RN and LPN applicant should be asked to present a current license. Examine the license carefully for authenticity. The Board of Nursing welcomes calls from employers to the Board office at (314) 751-2334 to verify the license of every RN and LPN you are considering for employment. There is a lot that can happen to a license in a twelve month period of time which may not be evident by merely requesting to see the license. This will become particularly important in 1991 when nursing licenses will be issued for two year periods.

Another advantage to verifying licenses with the Board office is in regard to the Tort Reform Law and the Board of Nursing's Mandatory Reporting Rule (refer to the Spring, 1989 Newsletter). The Tort Reform law allows employers from hospitals and ambulatory surgical centers to receive information regarding nurses currently under investigation by the Board of Nursing, provided the complaint was initiated by a hospital or ambulatory surgical center. For example, if hospital "A" terminated Nancy Nurse for incompetency, and you are considering hiring this person at hospital "B", you would be told of the nurse's termination from hospital "A" and the nature of the complaint. The information on licensees currently under discipline with the Board is available to all nursing employers regardless of the type of facility involved. The only way the Board staff can determine when this information can be released and to whom is by verification of the license.

Therefore, the employer alert is ON! The following are guidelines for employers to consider when screening applicants for all RN and LPN positions. If at any time you question the validity of a RN or LPN license or need assistance in dealing with nursing applicants, please contact the Board office. If you have questions or concerns about the information available to

you under the Tort Reform Law, please contact Melinda Sanders, Discipline Coordinator at the Board office.

In closing, I remind you that the Board welcomes your calls to verify RN and LPN licenses. Please don't allow your lax licensure verification practices to put a nurse imposter to work for you.

****EMPLOYER ALERT****

GUIDELINES FOR IMPOSTER IDENTIFICATION

Due to an increase in the number of falsified applications in this office and identified impostors, the Board is asking employer assistance in the procedure of verifying licensure prior to employment. Please call the Board of Nursing office and we can easily verify a temporary work permit or status of an individual within minutes.

SOME EXAMPLES OF WHAT MIGHT IDENTIFY AN IMPOSTOR:

1. Applying for a position when there is no indication that those individuals have worked in the capacity as that in which they are requesting employment.
2. Do not have a current Missouri license or temporary work permit.
3. Do not produce a license at interview and/or have continued excuses for not producing a license.
4. Job references are not in order when contacted.
5. Educational background is not correct. Example: Indicates receiving a BSN from a program which does not offer a BSN.
6. Fraudulent license, temporary permit, or letter of verification. We have received licenses from other states that have been "home made" and recently discovered nurse impostors possessing altered letters of verification and temporary permits from the Board office.

Please ask for several types of identifying information. If you have any questions about the authenticity of documents from the Board office, please call - WE ARE HERE TO SERVE YOU.

SCHOOL REGISTRATION FEE

Annual Registration notices for all schools of nursing were mailed on April 20, 1989. The Board office has received a majority of responses accompanied with registration fees already. All schools must respond to this notice by June 1, 1989 to remain in compliance.

In the past the annual registration fees have accompanied the applications for continued accreditation, however, these two procedures no longer occur at the same time. To strengthen the distinction between these two procedures, the Board has decided to separate them. The applications for continued accreditation will be mailed to schools around September 1st as usual and the completed application is due in the Board of Nursing Office prior to October 15th.

NURSING PRACTICE DECISIONS

REQUEST May IV Certified LPN's connect premixed medication cassettes to PCA pump tubing? May they flush the PCA tubing and connect this to a venous inserted catheter?

DECISION IV Approved LPN's may connect premixed medication cassettes to PCA pump tubing. They may flush the PCA tubing and connect this to a venous inserted catheter provided the IV approved LPN does not program or set any function of the PCA infusion pump.

REQUEST: The Missouri State Board of Nursing implement regulations to provide certification of nurse midwives in lieu of certification by American College of Nurse Midwives.

DECISION: Nurse midwife certification is not currently within the purview of the Missouri State board of Nursing. However, the Board currently has an advanced practice task force in place to study the feasibility of regulation of advanced practice.

ADVANCED PRACTICE TASK FORCE

The members of the Advanced Practice Task Force met on March 18, 1989 at the Holiday Inn in Jefferson City, Missouri. The members of the Task Force reviewed the results of a survey sent to other states that regulate advanced practice. The members of the Task Force made the following decisions at this meeting: 1) The State Task Force develop a plan for identification of and criteria for advanced nursing practice. 2) The Task Force expand to include a member from NACOG and a member from NAPNAP.

The members of the Advanced Practice Task Force also met on May 15, 1989 at the Harry S Truman State Office Building, Jefferson City, Missouri. The following decisions were made at the meeting: 1) The Task Force not expand any further at this time. 2) The Task Force adopt a working document that states the definition of advanced clinical nursing practice is a nurse who is licensed as a registered professional nurse under the provisions of RSMO 335.11 to 335.096; and holds a masters degree in nursing or is currently certified for advanced nursing practice by a national certifying body whose certification program is recognized by the Board.
