

**DIRECTIONS TO DIVISION OF PROFESSIONAL REGISTRATION
MISSOURI REAL ESTATE COMMISSION**

FROM ST. LOUIS – Take I-70 West to Kingdom City (148 mm) and exit ramp on the right. Turn left and take Hwy. 54 West to Jefferson City. After crossing the Missouri River Bridge, take Highway 50 West toward Sedalia to the Truman Boulevard exit. Turn left at the top of the exit ramp and drive over Highway 50 and turn left (at the second stoplight) onto Missouri Boulevard. The Division is the fifth building on the right. Turn right on Howerton Court and make an immediate right into the Division's parking lot. Ask the receptionist at the front desk for the Missouri Real Estate Commission. As an alternate route, take I-44 to Union, then Hwy. 50 West into Jefferson City.

FROM KANSAS CITY – Take I-70 East to Columbia (128 mm). Turn right onto US 63 South. Take US 63 to Hwy. 54 West to Jefferson City. After crossing the Missouri River Bridge, take Highway 50 West toward Sedalia to the Truman Boulevard exit. Turn left at the top of the exit ramp and drive over Highway 50 and turn left (at the second stoplight) onto Missouri Boulevard. The Division is the fifth building on the right. Turn right on Howerton Court and make an immediate right into the Division's parking lot. Ask the receptionist at the front desk for the Missouri Real Estate Commission. **** As an alternate route, take Hwy. 50 East into Jefferson City to the Truman Boulevard exit.

FROM LAKE OZARK – Take Hwy. 54 to Jefferson City. Take exit ramp to Highway 179 North. Turn left onto Highway 179. At second stoplight turn left. Go up to stoplight and turn left onto Missouri Blvd. After first stop light get in left lane. Left lane dead ends at Howerton Court. Turn left onto Howerton Court and then an immediate right into the Division's parking lot.

OR

Take Highway 54 East to Highway 50 West toward Sedalia. Exit right at Truman Boulevard exit. Turn left at the top of the exit ramp and drive over Highway 50 and turn left at the **second** stoplight onto Missouri Boulevard. The Division is the fifth building on the right. Turn right on Howerton Court and make an immediate right into the Division's parking lot.

**DIRECTIONS TO THE CRIMINAL RECORDS CENTER
OF THE MISSOURI STATE HIGHWAY PATROL FROM MREC OFFICE**

Turn right onto Missouri Boulevard and go through the second stoplight. Turn right on the first exit ramp to go around the clover leaf exit and then turn right onto the entrance ramp for the eastbound lanes of Hwy. 50. Take Hwy. 50 East, to the Clark Avenue exit. (You will pass through five stoplights in the downtown area. Clark Avenue is the second exit from Highway 50 East after going through the fifth stoplight at Monroe Street.) Turn right onto Clark Avenue and then make an immediate left turn onto Elm Street. Take Elm Street to the Highway Patrol Headquarters, approximately ½ mile on the right. Take the second entrance to the Patrol Headquarters. This entrance is marked with a yellow sign that says "Criminal Records".

**DIRECTIONS TO THE MISSOURI SECRETARY OF STATE'S OFFICE BUILDING
FROM MREC OFFICE**

Turn right onto Missouri Boulevard and go through the second stoplight. Turn right on the first exit ramp to go around the clover leaf exit and then turn right onto the entrance ramp for the eastbound lanes of Hwy. 50. Take Highway 50 East, to the first stoplight at the intersection of Highway 50 and Missouri Blvd. Take a left at that stoplight. Go to the second stoplight at Missouri Blvd and West Main Street and take a left onto West Main Street. The Missouri Secretary of State's office building will be on the right side of W. Main Street after crossing the railroad tracks. Short term visitor parking is available in front of the building.
